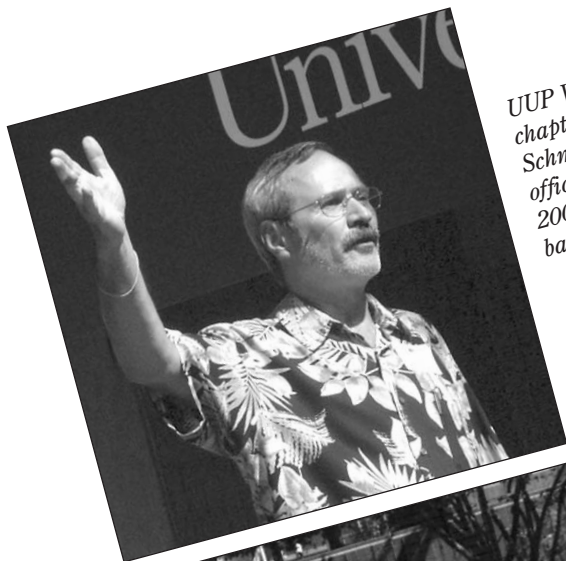


WELCOME BACK BARBEQUE A SUCCESS!

UUPers gathered at the Union Cafe on September 21 for our annual Welcome Back barbecue, which provided plenty of good food, conversation and smiles.



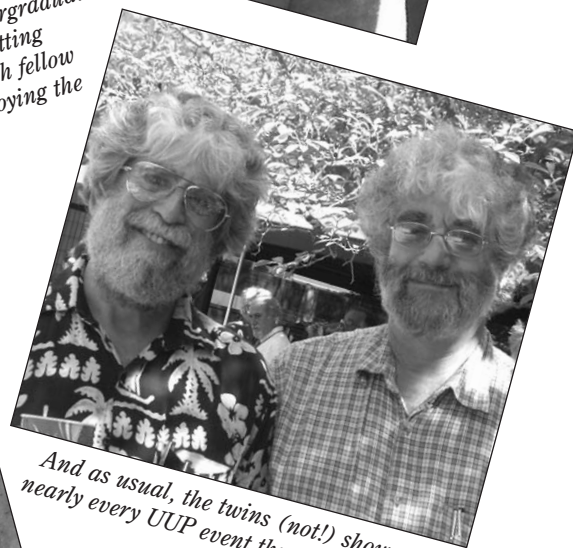
UUP West Campus chapter president John Schmidt introduces UUP officers to the more than 200 UUPers at the barbecue.



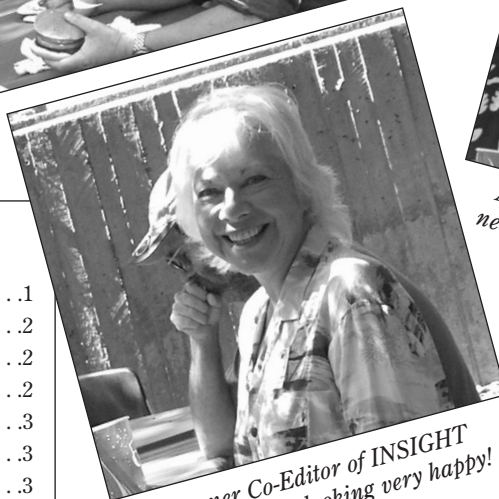
Tracey Iorio from the Undergraduate Transfer Office giving us a big smile!

UUP Defends Academic Freedom from New Attacks

You might think that academic freedom is a settled question, especially in New York State and within SUNY. But, as those who founded this country recognized long ago, “the price of liberty is eternal vigilance.” Pay attention today: academic freedom is very much in question, challenged by right-wing ideologues with innocent-sounding initiatives like the so-called “academic bill of rights (ABOR),” coupled with public denunciations of “leftist” faculty who are often called treasonous and un-American.

These winds have recently blown across the Stony Brook campus and elsewhere in SUNY. The SUNY Board of Trustees is considering adoption of the “Academic Bill of Rights” as are legislatures in some twenty states. The U.S. Congress has inserted ABOR language into the Higher Education Reauthorization Bill it is considering, and the Senate will take up the matter early next year. ABOR founder and conservative agitator David Horowitz has made clear the underlying political intent, despite reassuring appeals to academic freedom.

He writes that:

“Course content and reading lists in humanities and social sciences will reflect diverse concepts and viewpoints - not just the overwhelmingly leftist content that is being fed to our college students today,” and urges followers to “publish and distribute 250,000 more copies of our new booklet, *Unpatriotic University*. The booklet gives a wealth of information about the bias in hiring, the anti-American rhetoric, and the shutting out of conservative points of view both in classrooms and on speakers' platforms.” (see www.FrontPageMag.com for details).

ABOR would impose external political review of our curricula and hiring, severely undermining the integrity of our teaching and research. It would embolden students to claim political discrimination by faculty when the student's views are judged inadequate to the academic standards of the subject matter.

UUP and our national affiliate the American Federation of Teachers are leading the resistance to this pernicious development (see UUP President Bill Scheuerman's column in the April 2005 Voice at <http://uupinfo.org/voice/apr/05/apr05.html> and AFT's statement at <http://www.aft.org/topics/academic-freedom/>).

UUP has a new state-wide committee on academic freedom on which I serve. If you have experienced ideological challenges to your teaching or research, or would like to know more about this issue, please contact me.

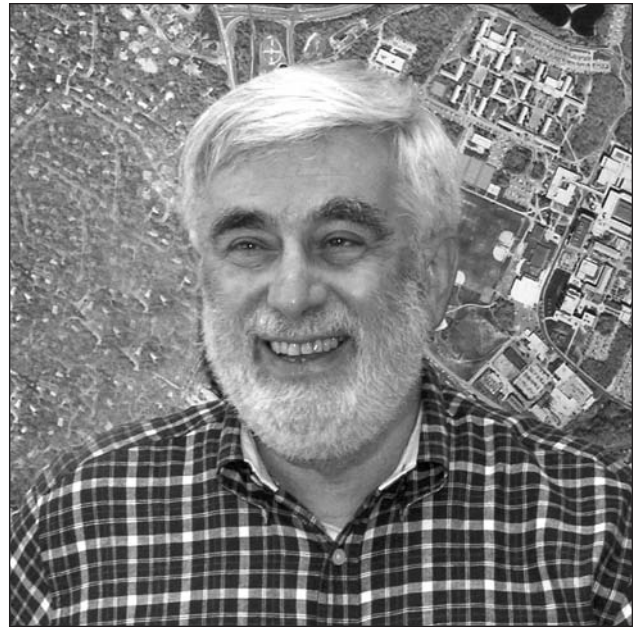

Some individuals have already asked to serve on a Part Time Concerns Committee to address pertinent issues, ask pointed questions and propose positive solutions. We need more and I think you are out there waiting to be asked or invited. So, consider this your invitation to "light a candle" rather than curse the darkness!
