# STATE UNIVERSITY OF NEW YORK COLLEGE AT NEW PALTZ

#### **2009 CAMPUS STATEMENT**

SUNY New Paltz traces its beginnings to the year 1828, when a group of leading citizens founded the New Paltz Classical School. Five years later, with the promise of financial support from the New York State Board of Regents, local citizens gathered funds to expand the school to a full-fledged Academy overlooking the Wallkill River. It is nestled in the shadows of the Shawangunk Mountains halfway between New York City and Albany. Today, the main campus has 63 buildings, including 15 residence halls.

The College's emphases in capital planning are to improve existing buildings (including the addition of modern educational technology), to improve the appearance and functionality of campus, and to address long-term program needs. The College plans to remain at about the same enrollment at the undergraduate level and to increase graduate enrollment in areas that do not require specialized facilities. This is appropriate because the College is using its facilities very effectively, with little excess capacity. Growth of even a few hundred students would require increasing facilities in a broad range of areas - general classrooms, specific instructional facilities; academic support facilities; and student support space.

Recent capital improvements funded from the capital plan include the complete renovation of van den Berg Hall, which houses the School of Business and the Department of Nursing (2006); a new Athletic and Wellness Center that includes a basketball arena, fitness and weight training rooms and an enclosed running track (2006); partial rehabilitation of the Central Heating Plant (2007); renovation of the Haggerty Administration Building basement (2007); and the installation of emergency generators for the Central Heating Plant and the Administration building; and an upgrade of HVAC systems in the Humanities Building and Jacobsen Faculty Tower (2008). More modest capital improvements have also been made using campus funds.

The following major projects are currently under way: replacement of high temperature hot water lines across the entire campus (begun in 2007 and slated for completion in 2009); an addition to the Student Union Building (construction began in fall 2008 with completion slated for spring 2010); the renovation of the Old Main Building, which houses the college's School of Education and will house several College of Liberal Arts and Sciences departments (construction began in summer 2008 with completion slated for 2011). Funding has now been obtained—and preliminary planning work is underway—for (1) renovation and reorganization of the Sojourner Truth Library, (2) a new Science Building to be located at the northeast entrance to the campus, (3) renovation of the Wooster Building, (4) replacement of the campus electrical distribution system, (5) upgrade of the campus wide energy management system, (6) renovation or replacement of the pool in Elting Gymnasium and (7) upgrades and renovations to the Central Heating Plant..

In 2007-08, a Campus Facilities Planning Task Force worked with EEK architectural/planning consultants to develop a comprehensive plan for overall campus aesthetics, pedestrian and vehicular circulation, accessibility, and environmental sustainability. This plan also determined the appropriate future location of building projects New Paltz plans to undertake in the next decade, including the above-mentioned Science Building. Funding is in place and planning is underway to implementing the Task Force's landscaping and aesthetic recommendations, including but not limited to site renovation and landscaping following completion of the high temperature hot water line replacement project. Currently, the campus has assembled a taskforce that is working with the SUCF and EEK to conduct a campus space utilization maser plan as a tool to assist the campus with the formulation of our next capital plan in 2013. A major campus development was the 2007 acquisition by the New Paltz College Foundation of a 42-acre parcel of undeveloped land contiguous to the southern border of the campus. This Foundation-owned land will be developed for faculty/staff and student housing.

The college's highest priorities for major renovation/construction projects are: (1) renovation of the Wooster Building; (2) renovation of Elting Gym, primarily replacing the old pool with an NCAA regulation-size pool; (3) continued refurbishment of the Central Heating Plant; (4) upgrading the campus electrical distribution system; (5) other enhancements to campus-wide utilities; (6) renovation of older residence halls; (7) construction of a new residence hall and dining hall (7) renovation of the Smiley Art building and (8) the relocation/renovation and/or construction of a building to house the University Police Department.


