President's Message

Opportunities for Your Voice To Be Heard

Please join me in congratulating **Carol Gizzi**, our President Elect; **Bruce Zitkus**, re-elected for a second term as our Vice-President for Academics; **Carolyn Kube**, newly elected Vice-President for Professionals; **Charles Hines**, re-elected for a second term as Treasurer; and **Bill Giangarra**, newly elected Part-Time Concerns Officer along with our newly elected and re-elected group of academic and professional delegates. This election saw an increased number of candidates both for officer positions as well as for our 50 delegate positions. This level of interest and willingness on the part of members to participate in the work of the chapter is terrific and historic. That is the good news. The disappointing news is in the percentage of our members who participated by mailing in their ballots.


As of the December 2010 membership certification date, we had 3,471 eligible voters, 852 of whom took the time to mail in their ballots (24.5 percent). The eligible number of academic voters was 1,401 with only 180 sending in their ballots (12.8%) and of our 2,070 professionals, 672 (32.4%) voted.

Our chapter officers and delegates help determine the direction of this union at the chapter and statewide level. They represent our membership at various UUP committee meetings and meetings of our affiliates - NYSUT and AFT. Our current slate of delegates will soon vote in an election at our May delegate assembly for statewide offices of President, Secretary, Membership Development Officer and for eight members of the statewide executive board.

Those who did not vote in this election missed an important opportunity to have their voices heard regarding the direction of the union. Those who did not vote allowed a small percentage of the membership to decide for them who will hold these important delegate and officer positions. Our members will not have to wait two years for another opportunity to participate in our elections. By the time this edition of *Bridges* is distributed to the membership, we will be in the midst of a runoff election for chapter secretary. This runoff is necessary because none of the original four candidates received 51% of the vote. **Tina Manning** and **Bruce Kube**, the top two vote getters, now must face off in this election. Please read their statements on page 4. Your ballot must be received in Albany by 5PM on Wednesday, May 4 to be counted.

Take advantage of this opportunity and cast your vote. All over the country there are those trying to silence the voice of unions. At rallies all across the country - including the recent We Are One rally in New York City (Saturday April 9) - union members and supporters gathered in support of worker's rights. The right to vote was a hard-earned one. Don't take it for granted. Elections matter. You have a voice, use it, and vote.

Myth Busters: Setting the Record Straight on Public Employees

Over the last several months, commentators, media outlets, and politicians have been on a tear, ripping public service union employees — including NYSUT members — and blaming them for the fiscal crisis many states are facing, and yes, even for creating the Great Recession. (Hello? Remember the real estate bubble?) We set the record straight on some of the more outrageous claims.

MYTH: The average public service employee makes far more than a private sector employee. Some governors are using this statement to drive a wedge between private and public workers and put an end to collective bargaining.

TRUTH: According to a new analysis by the Economic Policy Institute, state and local public employees are compensated, on average, 3.75 percent less than workers in the private sector.

The study factored in education, experience, hours of work, organizational size, gender, race, ethnicity, and disability. It found that, compared to private sector workers, state government employees are under-compensated by 7.55 percent, and local government employees are under-compensated by 1.84 percent. The study also found that the benefits state and local government workers receive do not offset the lower wages they are paid.

MYTH: Bargaining rights for public employees are the reason state deficits have exploded.

TRUTH: If you haven't read the column "The Shameful Attack on Public Employees" by former U.S. Labor Secretary, author and professor of public policy Robert Reich, now is the time. We've posted it on http://blogs.nysut.org/

It's curious, he writes, that when it comes to sacrifice, railings by Republicans don't include the richest people in America. "To the contrary, they insist the rich should sacrifice even less, enjoying even larger tax cuts that expand public sector deficits. That means fewer services, and more pressure on public employee wages and benefits. It's only the average workers — both in the public and private sectors — who are being called on to sacrifice."

MYTH: Public employee pensions are bankrupting state budgets.

TRUTH: AFSCME, one of AFT's and NEA's national labor allies, represents more than 1 million public employees. An FSCME December fact sheet clearly makes the case for publicly funded pensions. "State and local government pensions are, for the most part, well managed and not the source of budget problems for most governments. In 2008, state and local government pension expense amounted to just 3.8 percent of all (non-capital) spending. Contributions are expected to increase in the future to cover for investment losses and many public employers' failures to adequately contribute in the past. However, the increase in contribution rates will result in pension costs, in aggregate, approximating a still-manageable 5 percent of state and local government spending by 2014 and beyond."

The National Association of State Retirement Administrators said public pensions have exceeded the expected rate of investment return by 1.5 percent for a 25-year period beginning in 1985.

Individual Development Award Applications

If you submitted an application for the Joint Labor Management Individual Development Award (IDA) Grant Program you can expect to hear a response to your application from the IDA committee by late May.

Professional Obligation of UUP members

According to the State University of New York Policies of the Board of Trustees (Article XI Title H): The Professional obligation of an employee consistent with the employee's academic rank or professional title, shall include teaching, research, University service and other duties and responsibilities required of the employee during the term of the employee's professional obligation.

The fundamental responsibility of UUP members is to meet their professional obligation. SUNY and UUP agree that UUPers have no defined work day and no defined work week.

As noted in a Public Employment Relations Board (PERB) decision from July 1999 regarding academics, Joyce Villa, the State's Assistant Vice-Chancellor for Employee Relations, testified that the only portion of the professional obligation which is tracked in terms of time spent is classroom hours. Length of workweek is not tracked because, "we have the concept of professional obligation, because much of what our faculty does is self-directed. We don't monitor their workweek in terms of hours."

If you have questions regarding your professional obligation, please call the chapter office to set up a confidential appointment to discuss your concerns with a chapter officer and/or with our labor relations specialist. The chapter office number is 444-1505.

New financial education services offer something for everyone

If you're looking for information on financial services available to you as a NYSUT member, NYSUT Member Benefits may have something just for you. Considerable efforts have been put forth in creating new printed material as well as new presentations. Both in-service and retiree members can benefit.

403(b) Field Guide. This booklet covers all

aspects of 403(b) plans and includes information pertinent to members not yet contributing to a 403(b) plan, those who are contributing, those nearing retirement, and those already enjoying retirement.

To get the free guide, you can view and print a copy from the Member Benefits website, www.memberbenefits.nysut.org, hit the "Contact" option on the site to send an e-mail request, or

call 800-626-8101 for a copy to be sent to you.

403(b) Provider-Specific Workshop. Member Benefits contracted with the provider of its endorsed Financial Counseling Program, Stacey Braun Associates, Inc., to conduct these workshops upon request from local leaders. The workshop covers detailed information on five 403(b) providers chosen by the local leader from a list of 10 popular 403(b) providers. Workshops review the features of each plan, comparing fees and benefits. These workshops are designed for in-service members.

Workshops have a registration fee of \$20 per participant and a minimum requirement of 30 participants. A local could schedule this workshop as a webinar for a fee of \$250.

Workshops will not address specific questions pertaining to an individual's 403(b) plan. Members with questions regarding personal 403(b) accounts or other financial planning issues will be directed

> to speak with their 403(b) adviser or their financial planner. For those who don't have an adviser or planner, information on the endorsed Financial Counseling Program will also be available.

Financial Planning Puzzle Workshop. Today's economy has clarified the need for a financial plan; unfortunately, for many, beginning a financial plan remains a daunting task.

This two-hour workshop, designed for in-service members, outlines the process, covering cash management, risk management, savings, retirement and estate planning.
