

FULL RIGHTS FOR HOUSE STAFF

As of February, 1980, those who occupy the job title of "Clinical Associate Instructor" and "Associate Instructor", generally known as house staff, will be covered under the term of the 1979-82 collective agreement between the State and UUP.

The understanding between UUP and the Office of Employee Relation is as follows: with regard to direct compensation, basic annual salaries for those who have been employed by Tune 30, 1979 will be increased by seven percent effective July 1, 1979. The State and UUP have agreed that for the first year of the agreement (1979-80), the one percent of the total salaries of the incumbent house staff position will be allocated to the State University for the purpose of house staff travel. These monies are to provide the house staff with an opportunity to attend professional meetings. Due to the lateness of the agreement by the State, the unexpended balance of monies for 1979-80 will be carried over into the following year.

KNOW YOUR CONTRACT

ARTICLE 7 - GRIEVANCE PROCEDURE

"A grievance is a dispute concerning the interpretation, application or claimed violation of a specific term or provision of this agreement."

Violation of the contract "shall be filed by an employee or UUP upon an employee's request with the College President within 45 calendar days of the date on which the employee first knew or reasonably should have known of such act or omission if that date is later."

Many members of the faculty and staff have been unaware of their rights and the time limits that they are required to follow. No matter how worthy a grievance or complaint may be, if the grievance is not filed in a timely fashion it will automatically be lost.

Please consult with your Grievance Chairperson or our UUP Field Representative if you have a complaint or suspect that a grievance has occurred.




