TETRACYCLINES MAY STABILIZE HEART ATTACK-PRODUCING PLAQUES IN ARTERIES

More than 20 years ago, Dr. Lorne Golub of Stony Brook University's School of Dental Medicine, began research that would lead to the development of a critical drug and the only FDA-approved, systematically-administered drug used in the treatment of periodontal disease, the major cause of tooth loss in the adult population world-wide. Today, at an important conference being held by the American Heart Association in Chicago, important new research was presented indicating that Dr. Golub's original discovery may also have important implications in the treatment of heart disease.

Golub and his colleagues, N. Ramamurthy and Thomas F. McNamara, conducted the research at Stony Brook that led to the discovery of Periostat®, which in 1998 became the second drug developed by a State University of New York institution approved for marketing by the FDA. It has gone on to become the leading treatment in the world for periodontal disease. Now Golub is co-author of a research paper that says this non-antibacterial formulation of a tetracycline-a, low-dose doxycycline that is the active ingredient in Periostat® also lowers c-reactive proteins in the plasma of patients with heart disease. C-reactive protein is a leading diagnostic marker of risk for future heart attacks. Periostat®, may block certain inflammatory mediators, or cytokines, and inhibit certain tissue-destructive enzymes or proteinases such as collagenase and gelatinase the biologically-active chemicals produced by inflammatory and other body cells that can destabilize the fatty plaques in diseased blood vessels. Heart attacks can result when pieces of these plaques float downstream, blocking smaller blood vessels leading to the heart and other organs.

Some of these findings were presented at the AHA's Scientific Sessions 2002 by Dr. David Brown, Director of Interventional Cardiology and the Cardiac Catheterization Laboratories at Beth Israel Medical Center in New York. Dr. Golub also attended the event as co-author of this scientific paper.

ANOTHER SUCCESSFUL MINI-MED SESSION

Another successful Mini Med School series has just ended. The success of this program lies primarily with the faculty, staff, and administrators who put a good deal of effort forth to make it run smoothly. Their interest and contribution to the program have made it a winner for the School of Medicine. Last year it earned a Congressional Citation for Public Service and The Men and Women of the Year in Medicine award from the Times Beacon Newspapers. The good feelings and enhancement to the Stony Brook reputation the 204 community participants derive from it could not be equaled through thousands of dollars spent in advertising.

Dr. Dario Gonzalez graduated Stony Brook School of Medicine (1979) and continued studies in the field of Emergency Medicine at Jacobi Hospital in the Bronx. In 1985, he assumed responsibilities as the Physician in Charge of Emergency Services at Queens Hospital Center, Jamaica, New York. In 1989 he became the Chief of the Department of Emergency Medicine. In 1993, he joined the New York City Emergency Medical Service as the Associate Medical Director and the Medical Director of Training. He has also become the Medical Director of the New York City Urban Search and Rescue Task Force. On April 19, 1995, he was deployed to Oklahoma City as part of the rescue effort for the Murrow Federal Building Bombing. He worked with the NY TF 1 for seven nights (7 PM to 7 AM) in the search for bombing victims. He was also served at the World Trade Center collapse on September 11, 2001.

Clinton T. Rubin, Professor of Orthopaedics and Anatomical Science, of the department of Biomedical Engineering has been named winner of the Elizabeth Winston Lanier Kappa Delta Award for 2003, by the American Association of Orthopaedic Surgeons and the Orthopaedic Research Society. This award is the highest given by this combined society recognizing outstanding research contributions to the understanding of musculoskeletal diseases. It comes with a cash award of \$20,000.

Arnold Katz, Professor of Clinical Surgery and **Maisie Shindo, Associate Professor of Surgery**, of the department of **Surgery** were honored by members of the Hope Missionary Baptist Church.

The New York State Department of Health has awarded a \$50,000 grant for a culturally-sensitive, web-based breast cancer education program developed by **Elinor Schoenfeld, Research Associate Professor** of the department of **Preventive Medicine**. The program, to be administered by the South Fork Breast Cancer Coalition and the Long Island Cancer Center, will provide individuals visiting the web site with information specifically tailored to their age, family history, and ethnicity.
