Do Votes Really Matter?

Questioning if Voters are Educated

November 7, 2000 marked the day of the most historic election of this generation and maybe many to come.

It had some of the most clearly contested political elections in several years. They were also fulyy equipped with both controversy and suspense. There is a chance Americans may still not know who their president will be after January 20.

Although, like most previous elections, there was a multitude of registered voters who just didn't bother to vote, this election had an increaase in voter turnout as compared to prior elections. And with the greater turnout there is still a question as to how many of these voters actually made educated choices. Thousands of college students on the Stony Brook campus cast their ballots on Tuesday and the same question was raised to them.

Joey Weiss is a sophomore and Israeli immigrant who just obtained his American citizenship. Weiss doesn't think the political choices made by college students are educated ones at all. "College students shouldn't be allowed to vote," Weiss said. "They don't pay attention to the issues." Weiss said that he felt that many people, not just students, see one aspect they like about a candidate and that alone finalizes their decision. "They just don't see the whole picture," he said.

Another sophomore, Corinne Leake, claimed to be an independent voter and she voted for Vice President Al Gore. Leake admitted to not really following the election. She didn't watch the debates or the rallies and appearances that the candidates made.

She said that she intended to but she either had school work or "it was just too boring." Leake explained why she voted for Gore. "I don't like Bush," she said. "He just doesn't have a trusting face."

Leake also voted for Hillary Clinton for the

seat in the New York Senate. "I don't really have a reason, I just don't like him," she said, referring to Clinton's opponent Rick Lazio. She said that she thought that it was time for a change, to let a woman try her hand in New York. "Give Hillary a chance," she said. "She deserves it."


Even students who didn't care too much for politics had their reason for voting the way they did. "I voted for Nader because I didn't like Gore or Bush," said freshman Tim McCarthy. McCarthy said that he heard that George W. Bush smuggles cocaine from Venezuela through a pipeline that is supposed to be used for oil. And his reasoning for his dislike of Gore is that he has no personlaity. "Gore is too monotone," he said.

McCarthy thinks that this country needs a president who is a ordinary person. He said that Nader never admitted to smoking marijuana. "He's a regular guy," he said, "that's what we need."

In Florida, about 3000 people claimed to have accidentally voted for Reform Party candidate Patrick Buchanan instead of Gore and about 19,000 people's ballots were deemed invalid because they punched the ballot card twice after they realized their mistake. Most would think this would have an effect on the way people followed the election. With Leake, she did become much more interested. She found the election a lot less boring. "All of my professors talked about it the next day in class," she said.

Nonetheless, the mishap in Florida didn't faze McCarthy at all. "It didn't make the election more interesting to me," he said. "There is always going to be some

kind of interruption between major parties."



Turning the Tables

University Police Questioned as to Whether or Not they Acted Correctly **During Last** Weekend's Fight




Although it has everyone on campus talking, the people involved with last weekend's brawl in the Student Union are keeping mum.

As Suffolk police investigate injuries sustained by one student and University Police launch an investigation as to proper police response time to the fight, the contents of meetings held between SPA security members, University Police and other campus administrators are remaining confidential.

Although official details have yet to be released, the claims that have come out say that the fight on Friday began when a fraternity began to "stroll" during the performance of an off campus group that came as the guests of a sorority. Strolling refers to the practice some fraternities engage in when they do a march type walk in a procession. Other factors were involved but apparently the performers got angry at the strolling and the fight broke out from there.

At this point, numerous other issues are involved including allegations that the sorority who invited



the performers did not go through the proper channels to have them approved. These reports are not yet available.

However, another allegation that is being publicly discussed is whether or not University Police proceeded correctly with responding to the fight. Last night in the Fireside Lounge, employees of SPA security listened intently as Doug Little, deputy chief of police, promised an investigation into the allegations of the police. "We work closely with you [SPA]," Little said. "If you are not comfortable with our services, something must be done about it."

Little said that the average response time of officers ranges between one to three minutes but SPA staff disputed that, claiming that it took at least ten minutes for back up to arrive to the Union on Friday. Little defended the actions of his officers, saying that at the time the fight broke out, the one officer on duty in the Union was doing the external rounds of the grounds.

Little said that external rounds of the Union are essential when there is a party. "It is not people on

> campus that we trouble with," Little said. "The biggest problem we have is off campus people." Little said that they come to Stony Brook to enjoy what the campus offers. "But they have no regard for this community," he said, "they are not one of our own." Problems associated with off campus guests have included vandalism, graffitti and other

damage.

Little then asked the staff to demostrate by a show of hands if they trust working with university police, to which SPA officers did not respond, clearly stating their disaproval of University Police.

Little defended the officers accused of poor action during the fight. "I know both these men, they are good men," he said. However, Little said that with official written documentation of students who claim they acted wrongly, an investigation will be conducted. "I guarantee that a compliant number will be pulled tomorrow, but I need documentation," he said.

When Little promised an investigation upon the documentation provided by eye witnesses, one student asked who would be conducting the investigation. "I know what you are asking," Little said. "You want to know if this will be on the level." Although he would be the one doing the investigating within his own department, Little promised to remain unbiased. "I don't want to have to stand up in front of you again and defend myself or my force," he said. Little also mentioned that as a 24 year veteran, he cares about the campus. "I care about this place and I am very proud of my police department.'

But not everyone was convinced with Little's \(\begin{aligned} \begin{aligned} \text{ST} & \text{ST} words. One SPA employee raised his hand and said that his speech sounded rehearsed and like that of a politician. Another student said that he was not 💂 answering any of the questions "You are dancing around the questions," he said.

But Little maintained that he was going to do the investigation. Although he said that many compliants wind up being unfounded, if an officer is found guilty, they may have to undergo counseling and further training. In addition, the compliant remains on their 2 file and it could prevent them from raises and promotions.

But that was not enough for some. After Little 2 asked all those with complaints to email him, one girl mumbled that Little was condescending. But he maintained that he was going to work hard on the matter. "We have to ensure that this doesn't happen again," he said.

Elie Wiesel Foundation Works to Get Young People Involved in Ethical Issues

For the twelfth year in a row, the Elie Wiesel Foundation for Humanity has been trying to get young people to think about and analyze the urgent ethical issues confronting them in today's complex world. The Prize in Ethics essay contest has been one way they have tried to accomplish this. The Contest has been up and running since 1989. Open to all full time juniors and seniors at accredited colleges and universities across the country, the Foundation offers suggestions as to possible essay topics. One suggestion is to contemplate how a moral society's perception of the "other" may result in social separation, prejudice, discrimination, hate crimes and violence. A second topic could be to examine ethical aspects or implications of a major literary work, film or piece of art. The contest also allows for the sharing of personal experiences. For this topic, the writer can discuss the most profound moral dilemma they have ever faced and what it taught them about ethics.

According to Natalie Valkancic, the administrative director of the Foundation, various topics have been submitted since the contest began. "Topics have really ranged through the years," Valkancic said. "One essay made a comparison between women during the war in Bosnia and the Trojan war, another discussed ethics in the novel To Kill a Mockingbird and another one was about the writer's personal experience growing up in Vietnam," she said. "It is really open to anything."

Valkancic said that each year close to 400 essay entries are received but with the recent creation of the Foundation's website, those a

numbers are increasing.

Elie Wiesel The Foundation for Humanity was started in 1986 by Wiesel and his wife Marion after the Holocaust survivor won the Nobel Peace Prize. According to the Foundation's website, their mission is to advance the cause of human rights by creating forums for the discussion and resolution of urgent ethical issues. To accomplish this mission, the foundation has sponsored international gatherings, bringing together scholars, artists, scientists, politicians and others to share insights and ideas and to propose more humane solutions to the problems of the world.

The Foundation also established a Humanitarian award which was created to recognize outstanding accomplishments which are consistent with the goals of the Foundation. Past winners of the award have been

Danielle Mitterand, first lady of France for her work with children in third world countries and Hillary Clinton for her advocacy for children and children's issues.

Wiesel was born in 1928 in Transylvania, now Romania, and at the age of 15, he found himself prisoner of the Nazis in Auschwitz

> concentration camp. Although he and his two sisters survived Holocaust atrocities, one sister and his mother did not and his father died in the Buchenwald camp just days before liberation. Wiesel's experiences

Valkancic explained that when the contest was first created, a campus coordinator was picked for each school. The essays produced by the school were then filtered by this coordinator \(\begin{cases} \equiv \left\) who would only send the top three. To Trust or Not to Trust

Doug Little. The deputy chief of University Police comes off as a very nice guy. He is always ready with a smile, he looks you in the eye when he talks to you and he always asks the name of the student that he is meeting for. Even better, he actually returns your calls. (Lots of administrators could learn a lesson from this, especially Carmen Vasquez, dean of students.) He comes across as very trustworthy and someone that truly does have the interest of students in mind. It's almost easy to feel safe and at ease when he says his trademark phrase, "This community belongs to all of us."

But the trust that Little and his department have enjoyed with relatively few problems and ill feelings is in serious jeopardy after last weekend's brawl that has left the whole campus talking and has left others nervous.

Details of just what happened at Friday's Union party are still very sketchy even close to a week after the incident took place. Because of the highly sensitive nature of what is turning into a criminal investigation, many of these details are not just sketchy but confidential at this time.

But one piece of information that has come out is that a number of students are dissatisfied with the actions, or perhaps more accurately the

There's something about inactions, of University Police in perceptive audience member dealing with the fight that broke out between off campus performers, fraternity and sorority members and eventually members of the SPA security force. Students that were witnesses to the event are alleging that while students fought in the Union, officers were slow to respond and in some cases did not respond even when on the scene. One girl claimed that she witnessed an officer look into the door of the ballroom, where the fight was taking place, talk into a walkie talkie only to shut the door and leave.

> Although he said that often allegations turn out to be unfounded, even Little admitted that these were serious allegations that warranted an investigation.

After requesting that witnesses lodge a formal complaint against the actions of officers on duty during the party, Little said that he was ready to conduct a full investigation as to the events of the night. When allegations are found to contain truth, the offending officers do face action such as counseling or further training.

Few disputed anything Little said. He said that he was proud of his force and that he did not like to stand and defend what he called 'good men." But he admitted that the claims of the thirty or so students who claimed to see incorrect behavior could not be dismissed.

He had them going until one

asked for a little more detail as to who in fact would be conducting the investigation as to the actions of the accused officers. Little may have lost all credibility when he said it would be him.

Who can blame them for being cynics? Although he assured that his investigation would be what he called "on the level" is that something we should just accept just because he said so? Little said that he wanted to avoid having to stand before students in the future and defend the actions of his staff. He promised a fair investigation to avoid ever doing that again. But after just admitting that he thought the officers to be "good men," is he the man to conduct a fair, impartial investigation?

This fight may have set a precedent for Stony Brook, however unfortunate precedent it is. But perhaps this the gateway to start something else new and call for a new way of investigation. Maybe it would be possible to have students members on a board of some sort, at the very

As nice and genuine as Doug Little is, he is after all, only human. His emotions could get the best of him and as impartial as he might hope to be, we should proceed with caution and a keen eye to be sure that the investigation is not only done, but done properly.



The Academic Judiciary of the College of Arts & Sciences reports on selected cases in which students have been charged with academic dishonesty. The report is prepared by the Executive Officer of the Arts & Sciences Academic Judiciary in the Office of Undergraduate Academic Affairs.

In accordance with federal and state laws governing the protection of student privacy, these reports exclude identifying information such as name, gender, course, and department. In some cases, details that could be used to identify people have been altered to protect their privacy.

A student with no prior record of academic dishonesty was referred to the Academic Judiciary for plagiarism. The student submitted a report that was discovered to include sentences that had been copied from a published article. The student waived the right to appeal that accusation and was found guilty. The penalty was a Q* and a notation of academic dishonesty on the transcript.

Two students with no prior record of academic dishonesty were accused of submitting identical papers to the same course. The students failed to appeal the accusation and were both found guilty. Both received a Q and a notation of academic dishonesty on their records.

A student with no prior record of academic

dishonesty was reported for having submitted plagiarized work. The dishonesty was discovered when the instructor found matches on the CD-ROM encyclopedia Encarta and on an internet reference site. The student failed to appeal the accusation and was found guilty. The penalty was a Q and a notation of academic dishonesty.


A student with no prior record of dishonesty was accused of cheating on an exam. The instructor noticed that several of the studentis answers were nonsensical but that they were reasonable answers for another form of the exam. The student was found guilty and received a Q for the course and a notation of academic dishonesty.


*The Q grade denotes a failure in a course by reason of academic dishonesty and is accompa-


nied by a notation on the transcript indicating academic dishonesty. The Q denotes a failure in the course by reason of academic dishonesty and is calculated into a student's grade point average as an F.

If you are a matriculated student who has never been found guilty of academic dishonesty and if you are interested in being asked to serve on a hearing board, please call the Academic Judiciary Office at 632-7080. You will be occasionally contacted and invited to serve. Hearings are scheduled at different times of the week and generally last 1-2 hours.

Driver Admits to Being Drunk and High Day of Accident

A former bus driver admitted he drank beer and used marijuana in between shifts the day he ran over and killed a Cornell University student.

Timothy Stranger, 37, of Newfield, pleaded guilty Monday in Tompkins County Court to criminally negligent homicide and to misdemeanor charges of driving while abilities impaired by drugs and operating a commercial motor vehicle while under the influence of alcohol.

As part of a plea bargain, prosecutors will recommend that Stranger serve one year in county jail when he is sentenced Jan. 3. Stranger faced a maximum of up to 4 years in prison.

The family of victim Michelle Evans, a 21-year-old junior premedical biology major from New York City, agreed to the plea bargain and sentence, said District Attorney George Dentes.

A Tompkins County grand jury in May indicted Stranger on 12 counts, including second-degree manslaughter second-degree vehicular manslaughter, which carry top penalties of up to 15 years in prison.

According to police reports and court documents, Evans was killed

March 16 while crossing a road on campus when the 35-foot-long bus struck her as it was making a turn. Police said the bus was overcrowded and it was rainy and overcast at the time of the accident.

In court Monday, Stranger admitted he consumed a six-pack of beer and smoked marijuana between shifts the day of the accident.

After the accident, Ithaca police charged him with driving with a blood-alcohol content between .04 and .07 percent, below the .10 percent threshold for private motorists but above the .04 percent limit for bus drivers. He was fired shortly after the accident.

Stranger had two previous drunken driving convictions, the most recent from 1991

The Evans family also has filed a wrongful death suit against Stranger, the Tompkins Consolidated Area Transit and its partners _ Cornell University, the City of Ithaca, and Tompkins

Syracuse attorney Robert E. Lahm, who is representing the Evans family, said the guilty plea bolsters the family's civil case.
