

# **Nursing Fellowship in Quality and Patient Safety** Enhancing the Role Bedside Nurses Play in Quality Improvement

The purpose of developing a Fellowship Program was to provide in depth education and experience in quality and patient safety to nurses at the bedside. Applications are solicited from each nursing division which includes a written essay.

The program is designed to meet specific objectives over a six day period of time; twice a month for three months. The program includes didactic content and opportunities for active participation. The nurses interact with a variety of key people devoted to the improvement of quality, patient safety, and

The program is evaluated in several ways including daily reviews, an overall program evaluation and input from Nurse Managers and Associate Directors. The evaluation results and recommendations are presented to the Fellowship participants and nursing leadership.

At the end of the program, the nurses are able to articulate what they have learned as well as their perceptions and recommendations for moving forward in their role as unit quality representatives.

The overall perspective gained from the program is that communication is the path to change and improvement. The nurses describe a better understanding of the processes related to quality improvement and the value of small tests of change. The value of being part of a team approach to improve patient care promotes a sense of cohesiveness within the hospital.


#### Staff Nurses Articulate a New Perspective

## Communication to all Staff Nurses


- ☐ Attend hospital quality meetings

## Fellowship Evaluation Results

- Offer the Fellowship program twice a year ☐ Have all current unit staff nurse quality representatives complete the program
- ☐ Extend the program to accommodate additional topics/skills/practice
- ☐ Incorporate a selected quality project into the learning experience
- ☐ Standardize unit education to utilize PDCA methodology





## Role of Staff Nurse Quality Representative

- ☐ Resource to unit Nurse Managers
- ☐ Resource to staff nurse colleagues
- ☐ Standardizes communication of nursing quality data to leadership and staff
- Initiates and participates in unit quality projects
- Participates in division-wide data collection and auditing
