Important Note:

This application is not intended for matriculated Stony Brook students. Stony Brook students seeking to enroll in this program should contact William Burford (William.Burford@stonybrook.edu).

This application is exclusively for use by the student seeking to enroll in Stony Brook University's Semester by the Sea: Southampton Arts at Stony Brook Southampton for Fall 2013 as a non-matriculating undergraduate. A non-matriculated undergraduate is a student who is taking undergraduate courses at Stony Brook, but not pursuing a Stony Brook degree.

The following are required to be considered for admission to Stony Brook University's Semester by the Sea: Southampton Arts at Stony Brook Southampton for the Fall 2013:

★ Your completed Semester by the Sea: Southampton Arts Fall 2013 Application.

★ Acceptance to the program is based primarily on your promise and motivation as a filmmaker or theater artist and less on your experience. Please attach to your application a statement of purpose of up to three pages describing what you hope to accomplish in the program and what motivates you to apply. We are interested in

your thoughts about how you will benefit from the experience of joining us and your insights into your own creative urges.

★ Because the program is intensive, evidence of your habits of scholarship and discipline is useful. Please provide official copies of all college transcripts (and high school transcripts and SAT/ACT scores for applicants with fewer than 24 college credits).

★ Secondary consideration will be given to your writing sample. Please attach to your application three to five pages of creative writing in any genre, to give us a sense of your aesthetics and style. The sample should be double-spaced, in 12-point font with your name on each page. If you are already making films, you may opt to provide a link to your work on YouTube or elsewhere instead of a writing sample.

Students from other institutions who plan to study at Stony Brook Southampton as visiting students should see a financial aid counselor on their home campus about continuing to receive financial aid.

Because enrollment in this program is limited, applicants are strongly advised to submit all application materials as soon as possible.
