1) Approval of Agenda and the February Meeting Minutes

2) Welcoming remarks and Presidential Activities Report

President Naydan informed senators that the decision of the first round of assignment of the professional retention funds has been delayed but it should be released soon and encouraged students to apply for it. She reported that the presidential search committee is committed to finding a new president before President Kenny leaves office in June. President Naydan also reported that the Stony Brook day in Albany was cancelled due to inclement weather the day before and that the 150 letters written by concerned graduate students were given to the state legislature and governor's office. She informed that given the budget cuts most departments had revised the amount of students admitted with funding into graduate programs. President Naydan also announced that the tuition waivers for teaching and research assistants was not threatened this year but could be threatened for the following year which motivated the university senate to pass a resolution on the issue

2) Stony Brook Child Care Services

A representative from Stony Brook Child Care Services, Mary Cain, explained the activities of the center and answered questions from the senators.

3) Teaching, Learning + Technology

David Ametrano presented to the Senate the plans of the division of Teaching Learning and Technology to establish a teaching assistant teaching certificate program to prepares graduate students to college teaching

President Naydan and Vice President Selterman explained the current situation given the financial status of the university and underlined the importance of the resolutions, two resolutions were approved unanimously one for Governor Patterson (see appendix I) and another one for the University Administration (see appendix II)

9) NYPIRG

A Representative from New York Public Interest Research Group was not able to attend the meeting

10) News and Leisure

Editor Frank Petrignani requested \$200 to hire freelance writers for the publication, the motion was approved unanimously. He also suggested the possibility of hiring members of the Stony Brook Hockey team to write 10 articles for 500\$ but no motion for those funds was put on the table.

Kira Schuman (History) motioned to open the proposed 500\$ in funds to all free lance writers, the motion passed.

A request for extra 500\$ in advertisement for the publication was tabled.

11) New Business

Kira Schuman (GSEU Business Agent) announced a GSEU general meeting on March 11th in sac 226. She also reported in CWA lobby day in Albany and reminded senators that positions as mobilizers are still open for several departments

Sozia Turek (Marine Sciences) announced a meeting regarding the RA Union first negotiation session, the meeting will be held March 12 at 7 pm on SAC 227. The first negotiation session will be on Monday March 16

Speaker Longobardi reminded senators that the agenda is sent in advance so business could be included before the meeting.
