2010-2011 UNDERGRADUATE STUDENT GOVERNMENT LEGAL COUNSEL CONTRACT ACT

An act to contract the legal services of the Law Offices of Rudolph F. X. Migliore, P.C.

Be it enacted by the Senate of the Undergraduate Student Government,

SECTION 1. SHORT TITLE

This Act may be cited as the “2010-2011 Undergraduate Student Government Legal Counsel Contract Act.”

SECTION 2. APPROVAL OF THE CONTRACT

The attached contract shall be authorized for approval by the Treasurer of the Undergraduate Student Government following the enactment of this Act.

SECTION 3. EFFECTIVE DATE

This Act shall take effect immediately following the enactment of this Act.

Dear Ms. Ro:

Thank you for retaining this firm to serve as General Counsel to the Undergraduate Student Government at Stony Brook State University, and to operate a Legal Clinic on campus to address legal needs of the students.

It is anticipated that the legal clinic will operate every other Wednesday, approximately from 3:00 pm thru 6:00 pm, comprising of approximately 14 days per school year, commencing September 1, 2010. During those hours, students may drop in to discuss any legal matter of concern to them. Follow up letters or phone calls shall be included. Should the students need to engage my services, there would be a separate retainer from the legal clinic services.

As General Counsel to the Undergraduate Student Government, I shall address all legal matters affecting the Student Government. This shall include meeting with the Student Government, attending Student Government meetings as needed, and being available for telephone conferences pertaining to the Student Government as needed. It is anticipated that this shall require approximately five hours of my time per month, 12 months per year, commencing September 1, 2010. This retainer is structured in such a manner to allow flexibility in both the use of my legal services, and the needs of the Student Government in such a manner as not to be bound by time billing.

This office shall strive to provide full and complete legal services to the Stony Brook University Undergraduate Student Government in the most professional manner

It is mutually agreed that the fee for these services shall be \$41,500.00 per annum.
