- Senator Khan moved to approve the "Appropriations Act #11 for Fiscal Year 2010-2011."
- Debate:
 - Executive Council projects are voted upon by the Executive Council, to support programs in the university or to run its own programs.
 - O What kinds of programs will this fund exactly?
 - This is a discretionary spending fund. The nature of the programs is not known.
 Without having funds, however, EC members could not fund any programs.
 - o How much does the Leadership / Budget Workshop cost?
 - Around \$3000 on food and supplies. Costs are kept to a minimum.

- o Executive Council can also fund club proposals.
- O Which EC member is responsible for making these appropriations?
 - Any EC member can bring forth a proposal. It requires a majority of the EC to approve such a proposal.
- VP Forbes: I hope you guys are in favor.
- O Vote on the main motion: 18-0-1. (Roll Call #5.) Motion passes.

Agenda item 9.0: Undergraduate Student Government Stony Brook Volunteer Ambulance Corp Contract 2010-2011

- Treasurer Mark presented the contract.
 - Senator Khan moved to approve the "Undergraduate Student Government Stony Brook Volunteer Ambulance Corp Contract 2010-2011."

 - O How much money is earmarked for the Scuba Club?
 - **\$6,500.**
 - On the motion to amend: 1-17-1. Motion fails.
- Senator Fanizza moved to approve the "December 2010 Unrecognized Club De-Funding Act."
 - On the motion to approve: 18-0-1. Motion passes.

- Senator Abraham introduced the act.
 - o Senator Khan moved to approve the "Funded Organization Documentation Act."
 - o On the motion: 19-0-0. Motion passes.

 - o Decision: 16-3-0. Motion approved.

- The Chair announced that those attending in the gallery must now vacate the SAC Ballroom B, as an Executive Session has been approved.
- The USG Senate stood at ease at 8:03 pm.

 - o Vote: 9-9-1. Chair voted in the negative. Final vote: 9-10-1. Motion fails.
- Senator Giraldo moved to end the Executive Session.
 - o Vote: 18-0-0. Motion passes.
