## NYS Flex Spending Account (FSA) 2010 Enrollment Period

The 2010 enrollment campaign for the New York State Flex Spending Account (FSA) program will run from

**September 21, 2009 to November 16, 2009**. The FSA program is comprised of two important benefits for employees - the Health Care Spending Account

(HCSAccount) and the Dependent Care Advantage Account (DCAAccount).

Employees may contribute **up to \$4,000 per year** on a pre-tax basis through payroll deduction to an **HCSAccount** for eligible health care expenses

that are not reimbursed by insurance, and **up to \$5,000 per year** to a **DCAAcount** for elder care, disabled dependent care, or child care expenses.

The **FSA** contributions are deducted biweekly from the employee's gross pay and deposited to the appropriate account. Any money directed to a

**FSA** will reduce the employee's reportable federal, state, and social security taxes.

After eligible services have been rendered, the employee submits a claim form for reimbursement.

Employees are allowed to enroll in either or both accounts. Paperless enrollment makes it easy for employees to apply on-line or through a toll-free number.
