November 9, 2012 is the Deadline for the Flex Spending Account Sign-up

Friday November 9, 2012 is the deadline to apply for two Flex Spending programs offered by New York State. If you have signed up in the past, you must re-apply. The two programs available are: HCSAccount (Health Care Spending Account) and the DCAAccount (Dependent Care Advantage Account). The HCSAccount has a minimum sign-up of \$100, and a maximum of \$2,500 for 2013. It can be used to pay for medically necessary out of pocket health care expenses for you and your eligible dependents. The DCAAccount has a household maximum of \$5,000 pre-tax child care, disabled dependent care, or elder care expenses. If you receive 26 paychecks per year, this program will deduct from 24 of them, (if you receive 21 paychecks per year, the program will deduct from 19 of them.)
