### EXPRESS SCRIPTS DATA ISSUE

As you are, no doubt, aware many members received a letter from Express Scripts stating that personal data, such as Social Security Numbers and prescription information is likely compromised. Some campus HR Departments have also notified members of this and have confirmed this is not a hoax.

Express Scripts has set up a Web site: [www.esisupports.com](http://www.esisupports.com) This is for individuals to begin the process of protecting themselves from Identity Theft. I share your distress over this revelation--as I was a recipient of the letter, which has me rather concerned. To indicate how "Out of the Blue" this came let me quote part of an email I saw from GOER: "The Employee Benefits Management Unit (EBMU) at the Governor's Office of Employee Relations (GOER) was totally unaware of the breach and equally unaware of the letter distribution. Our first indication was when our Empire Plan unit enrollees received their letters at home (yesterday). This was as much a surprise to us as it was to you."

UUP is currently investigating how to best protect our members. And, I'll let you know what we find ASAP. In the interim, I strongly suggest that members avail themselves of the information at the above Web link.
