



# Illegal Immigrants Receive In-State Tuition

Among other honors, Stony Brook was ranked as the 10th best public university in the United States by US News & Review. It is therefore little surprise that it attracts local students seeking reasonable college tuition as well as students from out-of-state and from around the world. But what may come as a surprise is that while out-of-state students pay more than twice as much as in-state residents, illegal immigrants living in the State of New York receive standard in-state tuition.

In 1996, the Congress passed the "Illegal Immigration Reform and Immigrant Responsibility Act," which prohibited states from granting in-state tuition benefits to illegal immigrants unless the same benefits were extended to all Americans. The law often went unheeded in New York State until a 2001 review by CUNY officials discovered their tuition policy violated federal law and was temporarily suspended. With the support of Governor Pataki, however, a 2002 law re-extended in-state tuition benefits to illegal immigrants.

According to the National Conference of State Legislatures, 10 states have granted illegal immigrants in-state tuition benefits contrary to the spirit of federal legislation. New York, like other states, avoid penalty by not asking students their immigration status. Rather they base their tuition rates on whether they graduated from a New York high school. New York also requires applicants who are eligible to sign an affidavit that they will apply for legal immigration status.

Opponents claim that because the number of available slots at universities is limited and tuition costs are rising, the law is unfairly favoring the interests of illegal immigrants over those of Americans or legal residents.

"I felt a little upset," Virginia Morgan, a resident of Pennsylvania and recent graduate of Stony Brook University, told The Patriot when she learned about New York's policy. "I spent roughly \$37,012 out of pocket for my three years at Stony Brook," she added, "yet people who have entered this country illegally and chose to remain in this country illegally paid far less than me, simply because they chose to illegally reside in New York State."

Supporters of granting illegal immigrants in-state tuition argue that minors should not be punished for their status, and that extending such benefits will help integrate immigrants into the American economy by giving them college educa-



tions they would otherwise be unable to afford.

However, despite fears that tuition increases would deter illegal aliens from pursuing their postsecondary education, when CUNY schools temporarily charged such students nonresident tuition in the spring of 2002, re-enrollment for illegal immigrants did not drop beyond normal levels.

A bill introduced by Assemblyman Bill Crouch (R-Guilford) earlier this year would go a step

further and exclude all illegal aliens from admittance to public universities in New York. Neither that bill, nor its counterpart in the New York Senate, have been acted upon for several months and are not likely to be passed into law.

# Village Police in Suffolk Breaking the Law?

In case you missed this one, the local police need to be policed. A class action lawsuit was filed and settled in U.S. District Court between Robert M. Coco and similarly situated persons and the New York Village of Belle Terre over this past summer. The lawsuit claimed that the Belle Terre Constable and/or police department issued speeding and other moving violation tickets under their authority as police enforcement agents. If you thought that they have the authority to write those tickets that put points on your drivers license, you would be incorrect.

The District Court decided that incorporated village police departments do not have the authority to write tickets for moving violation infractions. In fact, those village police departments in Suffolk County ceded their authority to the Suffolk County Police Department when the department was created in 1958. They can however issue parking and code violations within their jurisdiction. This does not rule out receiving tickets from State Police, Park Rangers or Suffolk Police whom are hired by some incorporated villages to write tickets: those tickets, I'm afraid are all legitimate... sorry.



If you had received a ticket in an incorporated village from a village police department you would have been able to receive some compensation for your troubles, but the time to file a claim has run out. You can, however, speak to the New York State Department of Motor Vehicles about any points that accrued on your license. Some incorporated villages such as Port Jefferson and Islandia actually hire Suffolk County Police to write tickets for their towns and you actually have to go to their traffic courts to pay the fines. So heads-up people: be careful on the roads out there.

# Possible Loophole to Avoid Points on Your Driver License

# Midterm Election Results and Basic Economics in Brief

It's of course always preferable that our politicians get bogged down in bickering debate as opposed to actually enacting legislation; because at this late period of the republic anything they manage to accomplish must necessarily represent an infringement on our liberties, and/or the destruction of our economic well being. The fact is that this election only represents an ever so slight shift in the legislature. Its character is now authoritarian with a slight hint of democratic socialism, as opposed to economic fascism. The National Security State will go on, as will our newest war for eternal peace. means, plainly and simply, that a large number of free and voluntary wage contracts are now outlawed and hence that there will be a large amount of unemployment. Remember that the minimum wage law provides no jobs; it only outlaws them; and outlawed jobs are the inevitable result."

Luckily, the Democrats aren't stupid enough to attempt a raise in the minimum wage of any more than a few cents at any given time. Though if their logic does hold, one wonders why they don't simply raise it to \$10 or \$20 or \$100 an hour? We aren't dealing with complete imbeciles, and thus we are unlikely to see any serious economic strife with a minimum wage hike; though a few wage earners will feel it as they are priced out of the job market: those who are relatively unproductive, have few skills and can least afford to go without employment for long.

# Power Politics Democratic Party Style

Since the beginning of the campaign season for the mid-term elections, certain scandals have come out of the beltway as the bastard children of politics. # December Who is Rabbi Adam?

Although I don an untrimmed beard, wear a black hat and am called "Rabbi," I actually grew up as the average American. My childhood consisted of television cartoons, school lunches and playing kickball. As I got older, and entered high school, I searched to join a social clique, find a girlfriend and maintain an active social life that was pretty much divided between going to the movies, hanging out and occasional parties. If I thought life was great, once I got to college, life got even greater. In being that I grew up in the Boston area, the natural thing to do was to enroll in the University of Massachusetts, UMass at Amherst. For an eighteen-year-old, UMass was a dream come true: 30,000 students, all between the ages of 18 and 25, all living within walking distance of campus, and a police fleet consisting of only 30 patrol cars! In short, the rule of thumb was - you can do whatever you want. And that meant: party, party, party.

For the studious who wanted to maintain a certain grade point average, partying was to only be done Thursday through Saturday nights. For the less studious, parties could very well be every night. For at UMass, you could always find something going on. And this was besides all the nightly bands, the bars on Main Street and the infinite lecture and movie series forever being hosted by the university's clubs and academic departments. Indeed, at UMass you could more than double major in socializing.

Have you ever seen a 1000 person snowball fight? Well, that's UMass for ya'. It was like a tradition. As soon as the first major snow fall allowed for one to make a snow ball, one dormitory quad would take on another quad in a massive snowball fight. And then, as the rules of mob rule would slowly take over, one half of campus would engage the other half in a massive snow ball fight. Of course someone would always have to ruin all the fun by starting more than just a snowball fight. In such instances, a few fists would fly and others would start hiding rocks in the middle of their snowballs. As a matter of course, someone almost always would get hurt. For after all, aren't Friday nights made for going out? Well, that may very well be the case for the rest of the world, but that one particular Friday night I was stuck. No friends. No social life. No party.

# The Democrats and Hillary





# 18 Vs. 21: The Battle Over the Right to Drink Continues

Since the passing of the 18th Amendment, which created the prohibition of alcohol, and the 21st Amendment, which repealed prohibition and permitted the distribution and consumption of alcohol, the debate over the legal drinking age in the United States has been raging on for the better half of the 20th century and into the 21st

Currently in all 50 states, the legal drinking age is 21 years of age, as a result of The National Minimum Drinking Age Act of 1984. The argument for lowering the drinking age to 18 years of age has many in an uproar, however, it bears logic. On the one hand, organizations such as Mothers Against Drunk Driving (MADD) wish to keep the drinking age at 21 in order to maintain civility and prevent drunk driving accidents among teens and minors. # Large Misconceptions on Illegal Immigration

Three elephants led by a mariachi band illegally crossed the Mexican border into the United States, last month. The stunt was organized by a Pennsylvania congressional candidate trying to make a point. He succeeded in making it when border patrol didn't show up for a full hour.

Each year 500,000 people illegally enter the United States and join the 12 to 20 million illegal immigrants already here, cutting in front of the millions of people who wait months and even years on wait lists to enter this country legally. This cannot be allowed to continue. It is the responsibility of our government to take action and seal the border.

One of the most prevalent myths about illegal aliens is that they help our economy. Nothing could be further from the truth. Ac-

cording to reporting by Lou Dobbs of CNN, illegals aliens cost American taxpayers \$50 billion dollars in government services last year, in areas like incarceration, health care, education, and welfare. Some estimate that we spend upwards of \$70 billion. While one may argue that immigrants make up for the cost by paying taxes, this is just not the case. According to the Center for Immigration Studies, illegal aliens paid only \$16 billion in taxes last year, leaving Americans with at least a \$34 billion bill.

There is also the popular conception that our economy needs undocumented immigrants because they perform the jobs Americans won't do. This is also not true. The fact is most illegal aliens are in direct competition with Americans for jobs in farming, construction, transportation, food services, cleaning and even business management. One study published in the National

Bureau of Economic Research found that the surge of immigrants over the last two decades lowered the wages of American high school dropouts by 8.2 percent. The study concluded that Mexican immigration had played a role in the widening gap between the rich and the poor. A study by the Center for Immigration Studies reached similar conclusions: Between 2000 and 2005, the employment of immigration workers with a high school degree or less rose by 1.5 million, while the employment of American workers with the same education dropped by 3.3 million. In other words, illegal immigrants are taking American jobs, hurting the Ameri-

Another misconception of illegal immigrants is that they are only here to work. Unfortunately this is not always the case. A significant portion apparently has come here to commit crimes. According to CNN

reporting, while illegals make up only four percent of our population, they make up 30 percent of our federal prison systems. That's huge! And only 20 percent of them are here for immigration offenses. That leaves 80 percent who are imprisoned for crimes like drugs, stealing, rape and murder. When you have people freely crossing over the border, you can't screen them, and you don't know who you are getting. Incidentally three of the 9/11 hijackers were illegal aliens.


our country. Unlike legal immigrants, our government obviously doesn't have the opportunity to screen illegal aliens for communicable diseases, and as a result, our country is seeing a resurgence of contagious diseases that had previously been totally or nearly eradicated by our public health system. Some of those include tuberculosis, hepatitis, dengue fever, chagas, and

even leprosy.

In conclusion there shouldn't be anything holding our government back from sealing our borders. One can debate until they're blue in the face about what to do with immigrants already in the country, but any proposal is irrelevant as we are unwilling to stop any more from coming. Currently, we are spending only \$10 billion for border patrol, and the high estimates of the wall planned to cover 700 feet of the Mexican border is only \$2 billion.

That's nothing compared to the overall price illegal immigration is costing our country. Congress needs to spend more money, something they certainly haven't been shy of in the past, and increase the security along our border.

Now we have large and dueling groups of people who have become convinced that just because they're hurt or angry, just because they're for diversity or love this country, they have a license and duty to hurt their countrymen and relish their pain. Many of us who care about what direction this country moves in have become caught up in the brawl. We buy the hate artists' books, listen to news stories fed by their websites, and sneer at our enemies. In some universities students invite them to campus and administrators give them teaching

positions. We have cultivated a culture that degrades our common humanity over our differences. You can see from the Westboro Baptist Church's rage against the most innocent community in this country where this kind of exclusionist thinking and exhibitionism is leading us.

These are not the values on which this country was founded. Our second president, John Adams, and his party, the Federalists, were all but destroyed in their 1800 re-election against Thomas Jefferson. Yet they gave up power peacefully and allowed themselves to lose. They saw that their dreams might have to die, and inflicting much misery on the losers, in order for this country to survive. Would that we had the faith to remember that example today.

In our college campuses, too, there is something to be said about a culture that encourages people to express their own identity and value what others have to offer, even if half the students secretly hate each other. Most of all, the vast majority of radicals and confrontational activists one meets are genuinely nice people. When two people who are most unlike engage in a simple human relating, the world changes. One must confront the fact that one's adversaries are people, too.



This is the time of year when all the veterans are complaining that they don't get enough recognition. You know, no one goes to the Veterans Day parade, none of the younguns know what December 7 is. On top of that, we have a lot of people who when they do think about the military, look down on them with pity or scorn, as John Kerry's remarks some weeks ago enlistees that the War in Iraq was inadvertently revealed. We're not going to protect the United States from terrorists by asking them very nicely to leave us alone. We have to be able to marshal enough people to fight them. If we cannot understand or respect the ways of warfare, or if those we entrust with the power to fight our enemies simply do not share our way of thinking, this country becomes

Ever since Vietnam this country has been antsy about reinstating the draft. We should at least consider it as one of several ways to reintroduce Americans to service or defense of this country as something to which we can all aspire, and in which we are all invested in.

Israel has compulsive military service for just about everyone, some European countries compel a period of either military or volunteer service. In this country, which values individual choice, any compulsory service will be a hard sell, and perhaps we'll find a different

The bottom line, however, is that allowing the people and the armed forces to drift apart into radically different cultures puts all of our freedoms at risk.




