



# THIS ISSUE USG Passes ALIRRT Act

Can't afford that \$19 train ticket to get home to see the 'rents this weekend? Gotta visit the Metropolitan Museum of Art for your modern art class? No fear, the USG Senate is here. On November 28 the senate unanimously passed the ALIRRT Act (Affordable Long Island Rail Road Tickets) Act, giving Stony Brook students over a 50 percent discount on LIRR tickets to and from the Stony Brook train station and Penn and Jamaica stations.

The bill, written and introduced by Senator Joseph Antonelli, was passed by the senate last semester in an uncommon unanimous vote, giving students \$19 tickets to Penn Station at a cost of \$9 and \$13 tickets to Jamaica Station for \$6.

"This will give average students the opportunity to go to the city at an affordable rate," Antonelli said in an interview

last month.

The program will allow the USG to purchase 500 peak, round-trip tickets for Penn Station and 300 peak, round-trip tickets for Jamaica Station per month to be sold for half price to SB students. This will result in a cost of \$27, 400 per semester for the USG, funded by the student activities fee. The tickets will be available for sale to students at the USG ticket office in the SAC. Tickets won't be held for students at the office, but rather will be sold on a firstcome-first-served basis. Ticket purchases are limited to one ticket per week per student with ID.

The act came into effect in January over the winter session but will provide tickets for the first time in February. The bill stipulates that tickets will be ordered for the regular fall and spring semesters and will not be available for the months of June, July, August and January.

VP of Student Life, Trevor Hirst is in charge of monitoring the program and making sure it lives up to its expectations. The act says that if the program is unsuccessful and ticket sales are not worthy of keeping the program running, it will be reevaluated by the USG budget committee and voted on by the senate.

"This program will affect students in the pocket- saving a lot of money on train "This was designed to enhance the culture of the campus, making the city even more accessible for the students. I think that if it is advertised enough, it will be extremely

# Duke Lacrosse Players Vindicated?

Charges continue against the three Duke Lacrosse players despite the prosecutor's sole support being an incredible witness, with virtually all other evidence supporting the defense. It is now evident Durham County Prosecutor Mike Nifong pursued the case only for fame and political gain. The North Carolina Bar has recently charged him with ethics violations and will potentially provoke his law license, prompting Nifong to turn the case over to the state attorney general. But how many more months will this case continue? This case should remind of flaws in the justice system, and drive Americans to push for change.

The case began last March when two strippers performed at a Duke Lacrosse team party, after which one of the women claimed she was raped and sexually assaulted. Immediately the dynamics of the accusation grabbed media attention: this poor black college student and single mother was working as a stripper to pay the bills, only to be brutally gang rapped by racist rich boys from one of the most prestigious schools in the country. Nifong jumped on the case and used it to successfully get himself re-elected by a predominantly black community.

Yet as the story began to unfold, even the most sympathetic began to have serious doubts. The accuser made repeated and major changes in story, including first saying she was

assaulted by 20 men, reducing it to five, then to three, and then doubting whether or not she was raped at all. (While the rape charges were dropped, kidnapping and sexual assault charges still stand). The hospital records also said she had no injuries after the alleged attack even though she claimed to have been hit, kicked and strangled.

The accuser also did not consistently choose the same three defendants in the photo lineups and the only duke student she identified with "100 percent certainly" offered indisputable evidence he wasn't even in the same town when the alleged attack happened, and was resultantly not charged. Another defendant has similar evidence that puts him in the house with his accuser for merely a few minutes. Nifong stubbornly refused to drop charges against him

The accuser also said she didn't have sex for a week prior to the at-

tack, but had to backtrack when the semen of several men were found on her body, none of which were the duke lacrosse players (evidence Nifong deliberately concealed). This is despite her claim her attackers did not use condoms and ejaculated, and she had a rape kit administered only hours after the alleged attack; a combination of circumstances legal experts find extremely unlikely.

None of the different versions of time-lines the accuser constructed even make sense. Phone records show that in her newest version, she would be talking on the phone for three minutes during the attack. Perhaps most humorous is her recent claim that two of attackers went by multiple pseudonyms. While Dave Evans allegedly went by "Dan, Adam and Brett," Reade Seligmann used the names "Adam and Matt." Details on how ridiculous this case have become go on and on.

Not to mention the accuser's

damming history of criminal convictions, which include trying to run a policeman over with a hijacked taxicab, as well previously claiming she was gang raped, but refusing to give police an account of the alleged attack. In addition, the other stripper who attended the party reputed many of her claims and called the charges "a crock."

Nifong's role in all of this has been appalling. He allegedly allowed several tainted photographic lineups, deliberately and illegally withheld DNA evidence from the defense, and made hundreds of inappropriate statements to the media. Perhaps most shocking is that neither he nor any of his assistants had even interviewed the accuser for at least six months after they pressed charges.

His behavior should be no surprise, as power breading corruption is an axiom. This situation, however, should remind that the justice system is far from perfect, and the only difference between Nifong and other corrupt district attorneys is that he got caught.

At this point, most reasonable people are able to acknowledge the Duke players' innocence. Although the charges persist, the defendants have recently been allowed back into school. Yet as attorneys, editorialists and news anchors rush to offer analysis and condemnation, there seems to be a perspective that is absent from the reportage.

Innocent people are accused of crimes every day, and most do not have access to the resources that enables the Duke students to pay millions for a team of high-priced defense attorneys. If they are having such difficulty getting such ridiculous charges dropped, one can only imagine the frustration of our system for someone who is poor and uneducated.

What if the Duke accuser had pointed her finger at three impoverished African-American men instead of three privileged whites? It is likely the accused men would have been overwhelmed and pleabargained well before this point, putting them in prison for a crime they might not have committed. And the media would likely not even known the case existed, since the media rarely covers black against black crime, depriving the accused of a guardian and watchdog.

District attorneys can be political, corrupt and arbitrary and have access to government's immense resources. Nifong spent \$23,000 of tax payer money on a private DNA lab report after he was unsatisfied with the results from the government lab, undoubtedly only a fraction of the thousands he spent pursuing the case. In contrast, many defendants cannot even afford a lawyer and public defenders are often overworked, underpaid and unmotivated. This is a dangerous combination with respect to individual rights and liberty. There needs to be a mass infusion of money to fund legal services for the poor to mitigate the glaring inequalities that have become endemic in our judicial system.

# Fellows Program Great for Teaching Career

Graduation is just around the corner and if any of you are thinking of starting a career in teaching, especially you juniors out there, you may want to think about teaching in a New York City public school. You could also begin the long one year track to New York State certification or you could opt for the NYC Fellows Program.

The program was established in 2000 in order to the fill the need for teaching professionals throughout NYC. The fellowship program upholds the conviction that public schools can work, but that they must be staffed and led by people who are the most talented and accomplished. The program provides an alternate fast track to become an educator under the Transitional B certification while completing a Master's degree program. The short, intensive preservice training is provided by the fellows, who complete other academic requirements while they teach. The most outstanding part of this program is that the program pays for your Master's degree. In 2006 the amount a fellow had to pay for his or her Master's degree was \$4,000, and it was deducted in small bi-monthly debits from their teaching salary, which in 2006 was \$42,512 per year for a first year teacher.

The pre-service training is the key to



fast tracking your career as an educator. There are three main components which include: Master's degree coursework at an assigned university, field placement work during which fellows observe and assist New York City teachers in summer school classrooms, and attending teaching sessions during which they learn key instructional design and classroom management skills from an experienced teacher.

While the program offers outstanding benefits and is probably too good to be true, fellows are placed in high-need subject areas and in high-need schools. So, if your passion is history and your undergraduate degree is in history, you may be teaching math or science. Of course, once you have put in your three years, you will have tenure in the NYC public school system and can pursue additional certification for your key subject area. Some fellows have been hired just as trainers for other teachers.

The process is rather simple and intense at the same time. You go to www.nycteachingfellows.org and fill out an online application, which includes submitting a letter reflecting your view of why you want to become a teacher and fellow. This will be the letter that determines whether they schedule an interview, so make it count. Optimistic

and enthusiastic teachers are what they are looking for. If your application qualifies, they will set up an interview which will be rather intensive. At this interview you will be required to teach a five-minute lesson plan (which has a clear beginning, middle and end), have an individual two-minute written response to a problem that arises in your first few months as a teacher, and a twenty-minute group discussion with your fellow applicants acting as teachers. This is a problem-solving session and your responses and skills in debate situations are most important here. Before your twentyminute personal interview you will be asked to write a letter to parents who have lost faith in your teaching ability and you need to show them how you will respond to their concerns. While all of this sounds difficult and exhausting the hardest part is waiting to teach your five-minute lesson plan which they get out of the way first.

This senior has endured the processes to become a fellow and is presently waiting for a response. In 2006, the program received 17,491 applications and offered 3,494 candidates admission of which 1,700 began teaching. The program is both worthwhile and needed for New York City and the children under its educational care. So, if you are deciding on an educational career, this program is definitely worth a look!

# President Bush to Request Surge

#### Bush is Expected to Request 21,500 More Restroom Attendants in Wake of Athens Embassy Bombing





# PUTTING ROTH POND to the test

Each year, as part of a beloved Stony Brook ritual, teams of highly excitable college students wade into Roth Pond with barely buoyant cardboard contraptions, brightly colored and fashioned into novel shapes. High on school spirit and duct tape fumes, they proceed to race across this body of what is presumably water. Whether you're a yearly attendant at the Roth Pond Regatta, or if you just happened to catch the miraculous crossing of the clown, you probably have a few questions about the pond.

"Why is the froth brown?" "Does it always smell like that?" "Is that, um ... is that a desk in there?"

The answers to these three questions are "nobody knows," "yes," and "probably yours." Public opinion of the Roth Pond ranges from reserved disgust to all-out terror. But the question that nobody asks is: "Has the Roth Pond ever been tested? How badly will it disrupt my biological processes?" I don't know if Stony Brook has ever conducted an official test of the Roth Pond water. The website's search function is marginally functional, at best. So, armed with a drinking water test kit and a handful of rowdy lab assistants, I set out to determine once and for all just what is in that pond of ours.

As far as we know, the pond has yet to kill anyone, with dozens of students surviving each year's regatta. The test kit, however, allowed me to test for a multitude of factors that could render the water harmful, should you meet with the misfortune of swallow-



ing it. First up were the tests for nitrates and nitrites, harmful chemicals usually resulting from heavy use of fertilizers. The test showed no measurable amount of nitrates or nitrites in the pond. I was somewhat surprised, however, by the zero alkalinity and neutral (7) pH of the pond. I expected the decomposition at the bottom and the fish urine in the water to upset that one way or the other. The hardness test (for dissolved minerals) was a little difficult because the test strip really did not closely match any of the examples in the booklet. The closest, as I could determine, was 120 ppm (parts per million), which indicates very hard water. Don't quote me on that. It may or

may not be harmful, but is definitely not convenient to bathe in. After this one apparent blemish on the water's record of cleanliness, I was surprised to find zero concentrations for iron, copper, and chlorine. Pesticide and lead tests also came up spotless.

Needless to say, I was surprised. As I waited for the 48-hour bacteria test, I almost contemplated having a

Roth taste test. However, upon the return of the bacteria results, the water clearly tested positive for coliform bacteria. If you're not up on your biology—it comes from feces. So the bottom line is, if that pond somehow starts looking appealing to you ... do not drink it. It will probably mess up your entrails worse than Taco Bell found in the street. And that, ladies and gentlemen, is science.

What's better then playing a game that takes place on a frozen planet in the dead of winter? Apparently not much, since Microsoft placed its January sales in Capcom's hands in the hopes that the Japanese-based developer would deliver - and it certainly seems they have. Many critics were skeptical about Lost Planet, simply because they felt the game would seem monotonous, with the entire storyline taking place in the snow. Add that to the fact that most action adventure games' worst moments are during the infamous "snow levels", (a.k.a the "Hoth syndrome" - Alex), and you could see how some games were less then enthusiastic. It seems that Capcom has silenced the critics, managing to pull off a solid action game with some very cool moments involving large insect-like creatures (Because, you know, THAT hasn't been done to death - A.) that inhabit the planet. Lost Planet incorporates the use of mechs in a role that stays interesting, whether it involves needing more firepower to take down the game's monstrous bosses, or using them in several platforming elements (I never thought I'd see the day a game manages to ruin both mechs AND platform action for me - A.) to break up the shooting segments. 





# When Darkness Falls

Py day, Prakis was an ordinary enough city. Resting in southern Nyanesius upon the Fiorenan Peninsula, the first to rise in Prakis were the fishermen and longshoremen, and the docks were bustling with activity and labor by midmorning when the shops and markets would open. The local temples administered education to those less fortunate, while those that could afford it, usually nobles, had purchased tutors as slaves to teach their children to read the classics and learn the ways of civic life. Those studies would not end until the afternoon, when the students would return to their homes. Otherwise, most of the youth worked as apprentices with either their masters or their parents, to one day take over their trade or store, consigned to the business for the rest of their days. Much like other cities during this period, young adults would dream of adventure beyond the city's protective walls, and hearing tales of knights, dragons, or dark sorcerers, these city folk armed themselves and ventured out into the woods seeking the riches of Ulfelwyn, the lost elven kingdom, never to return.

Ruled by a long line of Dartotian nobles, Prakis' internal government had traditionally been one of relative stability. Though, that has not precluded the possibility of a family feud or the overthrow of one brother by a jealous younger sibling, as happened most recently

when Varius Nowell murdered Trudor to take rule in 897 SR. Only twenty winters old at the time, Varius slit his brother's throat while Trudor ate figs with his twin daughters, only six at the time. It was ordinary enough for the populace to accept a sudden change in ruling lords. So long as the noble family murdered each other, they would not be bothered with brutalizing the populace at large, or with raising taxes.

Such was the depraved yet inspired political vision of the regime. Despite the state-regulated prostitution and narcotics trade which corrupted the youth of Prakis and beyond, the waste of state revenue on sumptuous affairs, and a military draft which found Prakis' sons deployed throughout the region to deal with the emergence of the republic of Aten as Prakis' rival for supremacy of the Fiorenan Peninsula, the strong merchant class was allowed to profit from their surroundings quite comfortably. Even the mysterious rulers of the Darkwood, once the bright elven kingdom of Ulfelwyn, who had recently expanded their influence into Prakis, were welcomed by traders and shipping captains alike for the vast sums of bullion they invested into Prakis' economy. Even the corrupt temple to Dantuea, the cruel sister of the Earthdragon, served the ends of creating a power base for one of Danaa's most important religions,

the forbidden Dantueaism. Even with their horrifying activities of raising the dead, this too could be justified since necromancers and other pilgrims often visited Prakis as a holy city, as it was in this region that the dead first rose from the grave. These visitors too brought coin and sought lodging. Allowing the business interests to continue to make money had served the ruling family for centuries as a means to keeping the peace.

If one were to ask an Atenian historian at the time, with all of his biases, he might have reported that Prakis, since the fall of the elves from Ulfelwyn, had been dominated and thus ruled by the dark forces which replaced them. Varius the Cruel, Lord of Prakis, long familiar with these slights of Aten's academia, knew better. Even at his relatively young age, he knew that his ancestors of old had premised coexistence with the elves upon beneficial trade relations and the wide protection of having a strong kingdom on one's borders afforded, and so too must he deal with the rulers of the Darkwood, even their insane cult of the undead they brought with them. Business had never been better, and as long as he controlled a vast empire of wealth, power, militias, and consorts, the surrounding lands of Prakis, and most importantly, as long as the stream of revenue continued to flow into the family's coffers, he continued to trust in the wisdom of his forefathers.

He had spent much of his childhood studying the Nowell family archives, reading of their rise to power and the assorted betrayals and power plays that had colored their history, and soon he realized that there was no reason not to seize control of the city. Trudor was an oaf anyway, Varius had reasoned, trusting of his kin even in his dying breath, and certainly was not fit to oversee the family's multitude of operations, in particular the opium trade. The shipment of poppies from the Darkwood was the Nowell's most profitable of trades, and it gave Varius comfort to know that their corruption would weaken his enemies abroad. As long as the army and militias were well-disciplined, he reasoned, the negative effects upon the city's civilian population were negligible to him.

Instead, Varius was resolved to expanding his family's influence abroad. Recent

setbacks against Prakis' barbarian neighbors to the South, the Fratenics, had necessitated a new push be made not only to retake the fortress upon Rocky Point, but to use Prakis' naval advantage to begin laying claim to villages along the coasts of the Greysea. This would in turn shore up Prakis' control of trade from the Fiorenan Peninsula's east coast to the land's north and east. Soon, Varius thought, his grip would extend southward to Aten, securing their monopoly on steel. Like his predecessors, Varius envisioned expanding Prakis' empire to bring the whole peninsula under his rule. Only then, he thought, could Prakis control trade northwest through Nappol's Sea. Nevertheless, like his predecessors, Varius stood against some of the more formidable forces in the region: the Congress of Aten, the exiled elves of Ulfelwyn who had taken refuge in Atenwood, the grey dragons of Dragon's Claw, and the insurgent barbarians of the Nyanatzian Highlands.

During the first two years of his reign, Varius had invested much time into studying the politics of his rivals in Aten. He considered their polity, the competing noble families vying for control there, and also spent much coin to influence those politics. From within, he reasoned, the light of Aten could be extinguished. The free people there were her greatest asset, and so it was they who must be broken. Their pride must be countered, and their

exceptionalism destroyed. As much as he envied their wealth, he despised the idea that a commoner could become a delegate to Aten's Congress, and he feared that as republican rule spread throughout the region, so too might it one day find its way to Prakis. Varius also knew of Aten's special relationship with Danaa's greatest power, the Nyanatzian Empire. The longer Aten remained under popular rule, the more likely it was that the Empire would eventually send aid for Aten's war against Prakis. Indeed, undermining Atenian relations with the Empire was one of his main goals, since if he could rule out their intervention in the conflict he could continue to justify the costs of war to the lesser lords and ladies of the Prakitian regime. Adapting well to his role as Lord of Prakis, Varius since his ascension had been intimately overseeing the city-state's strategic interests with an eye to securing dominance over her neighbors.

The city's present engagements found its forces deployed throughout the Darkwood, along the northern borders with Thracedonia, on the island of Myneus off the coast of Thet, protecting traffic throughout the Greysea, especially high priority shipments, and of course, embroiled in sieges on Rocky Point and on Fratenic villages across the Nyanatzian Highlands. As

the campaign was about to enter its first summer, both the Atenian and Prakitian forces were busy fortifying their positions, supplying the front, and acquiring intelligence on potential maneuvers each side, Aten and Prakis, might engage in. Varius was not impatient and he was determined to bleed the Atenian occupation of Rocky Point by infiltrating the fortress and its surrounding villages, setting up sabotage missions, and slowly but certainly ensuring scores of casualties. As the war dragged forward, it would eventually come to pass that the current political opposition in Aten would achieve a majority, and both their rhetoric of withdrawing forces from Rocky Point and leaving the Fratenics and Prakitians to their own devices could become state policy.

As a matter of diplomacy, Varius had recently reached out to Atenian Congressional delegates to make overtures of peace, offering a treaty with Aten over the terms of the Fratenics' independence in exchange for a troops withdrawal and Atenian assurances that neither Aten or the Nyanatzian Empire would invade Prakis or take any more protectorates on Prakitian borders. Though those delegates were not warmly received in Aten upon their return, he knew that merely making the offer could win him sympathy in Aten, since Prakis had not overtly threatened Aten when the Atenians had intervened on behalf of the Fratenics in 898 SR to liberate Rocky Point from Prakis' control.

The loss of the fortress, Rocky Point, was a major setback for Varius, who had barely been in power for a year when the provincial control over it had fallen to Aten. Losing the trade route through the Fratenic lands west of Rocky Point was such an emergency that he immediately began making preparations for war. Varius was determined to use Aten's invasion of Prakitian lands to secure an alliance with the Darkwood and to rally the extended Nowell family with a common purpose. These demands of liberty from the Fratenics were just the beginning, he had argued to his fellow nobles, and the outcome of the war with Aten


# Safety Without a Veil of Secrecy

As I agonizingly listened, I realized how similar being a gambler in a airport casino is to being an American citizen. It is a little amusing, but true. As a citizen, especially in a political sense, political support is a gamble. Individual convictions are reached and support is given to a policy or a candidate in the hopes that it will pay off. Gallup and other companies poll Americans for our opinions on economic, social and other matters, and we hope that government leaders respond to these. We hope that our support will pay off, both for us personally and for our country.

The amount of energy and passion we invest in our political convictions vary. In some cases, if our ideologies do not become government policy, we are not overly worried because neither our security nor our system of government are placed in jeopardy. However, with other issues, the stakes are incredibly high. Some issues heavily influence the safety of our nation and our form of government. In the next few months, we will be confronted by an increasingly critical issue; the availability of information between the President and Congress. Congress often wants information, and in many cases, the executive would rather that information remain secret.

This issue is different from others, not only because it influences our security and



way of life, but because it is rarely resolved by the law. This issue is almost always decided by political pressures. Throughout American history, almost all conflicts over access to information between the President and Congress have been decided by politics. Both branches have innumerable tools with which to defend their claims. The President has precedent, the doctrine of the separation of powers, and most importantly U.S. v. Nixon. Congress has the undeniable power to investigate and inquire, the power oversight, and consequently it can use its authority to withhold funds and suspend appointments to compel disclosure. This often leads to stalemate. These types of conflict are rarely resolved by the judiciary, which usually refuses to adjudicate this political issue. Since the law cannot clearly solve this conflict, it is most often the voice of the American people that decides. It is clear that the rule of law becomes secondary, but this is an entirely different topic for another discussion. Let it

be simply reiterated that in this situation, the voice of the majority becomes the dominant factor of resolution.

Since the tragedy of September 11, 2001, conflict over availability of information has not been a major point of contention between federal branches. Several Republican controlled Congresses have allowed President Bush to withhold requested information, especially where the White House has declared that the "national security" is related. President Bush has made clear that if certain information is released to Congress, the safety of the nation will be jeopardized. His rhetoric in front of Congress on September 20, 2001 seem to be continuously repeated, "Our nation has been put on notice: We are not immune from attack."

We are now in the year 2007 and we are entering a new chapter of American history. The 2006 elections gave control of Congress to Democrats and they are not as willing as their Republican predecessors to allow the

President to withhold information. Speaking of White House information, House Majority Leader Steny Hoyer said that "There are going to be many, many hearings." On January 9, of this year, speaking of proposed troop increases, Senator Edward Kennedy demanded that "no additional troops can be sent and no additional dollars can be spent on such an [military] escalation, unless and until Congress approves the President's plan." He spoke for the Democratic majority of Congress, no additional support would be given to the President without Congressional access to national security information.

In the following weeks, and maybe months, there will be many Congressional hearings and much White House information will be requested. Each side, executive and legislative, will ask the American people for their support. It is likely that the White House will refuse to disclose some information and will insist that releasing information to Congress will threaten the security of the nation. It will claim that releasing information can only aid terrorism. In addition, it will add numerous arguments of legal and precedential nature. In reply, Congress will likely argue that the successful future of the nation depends on access to information and that the separation of powers, along with other legal mandates, require that President Bush release information to Congressional Committees. This will likely produce a gridlock in which the opinion of the American people will likely be the deciding factor. As Americans, as patriots, what should we do?

We must contemplate, we must think and we must weigh the options. By allowing President Bush to withhold information, we are supposedly keeping our nation safe from terrorism. But what do we sacrifice

will assume this is true, because technically to hate anyone is wrong, especially as a Christian.) - Given. P ---> ~Q


2. If a person does not hate gay people, they will not be against gay marriage. - Given.  $\sim Q ---> \sim R$

if we do this, if we turn our head and allow President Bush to withhold information that he has deemed to be related to the "national security?" 


