

To Slander The Past Is To Cheat The Truth

Today's political culture is said to be one of the most polarized in American history. There are those on the right who like to call President Obama a socialist. There are those on the left who accuse conservatives of being racist and only taking care of the rich and doing so at the poor's expense. Each side tries to exploit the lunatic fringe of the other side; whether it's the right pointing out the socialist and radical czars within the Obama Administration, or the left showing the deplorable actions of a few Tea Partiers. Each side makes their arguments, some valid and some skewed. But what is lost in this never-ending feud is the truth. For that, we must look to the history books. But, we must make sure we listen to both sides. The goal is to learn the truth, not one ideology's slant.

"History teaches everything, including the future," said Alphonse de Lamartine. The current textbook battle in Texas is one that could alter the course of the country. For too long, history books have been skewed to the left. The goal in Texas is to finally teach history the right way by looking at it from multiple points of view, including the conservative one.

The School Board voted to include curriculum that, according to the New York Times, discussed the "superiority of American capitalism...and present(s) Republican political phi-

losophies in a more positive light." They want to teach the history that typically is not taught in high school including "the violent philosophy of the Black Panthers" and the fact that it was Republicans who supported Civil Rights legislation. They want students to learn about "the unintended consequences of the Great Society legislation, affirmative action and Title IX legislation" as well as "stressing that Germans and Italians as well as Japanese were interned in the United States during World War II, to counter the idea that the internment of Japanese was motivated by racism." How many of the students who attend Stony Brook knew that about the WWII internment camps prior to reading it just now? I'm willing to bet only a handful at best. It's examples like that that the Texas School Board wants to correct. It's not about pushing an ideological agenda; it's about correcting previous education wrongs and showing history for what it is. What's scary is how much information that students today don't even know they aren't aware of.

Stony Brook University is certainly included on the list of schools that teach from a particular ideological view point. The following is meant to expose a handful of these examples and act as a counter to the University's stances, so that students are able to form a more complete opinion after hearing both sides.

Here are just a few examples straight from Stony Brook University where students are not shown the whole truth and instead pushed to endorse the school's left-wing position.

Part I

Leadership and Development's (LDS) theme of Social Justice. I cringed when I heard this at orientation. I was absolutely floored that a school with the prestige of SBU would endorse such a theme. Here's why:

On November 11th, 1934, Father Charles Coughlin founded the National Union of Social Justice. In 1936, he established the Union's 16 principles including:

1. A belief "in nationalizing those public necessities which by their very nature are too important to be held in the control of private individuals. By these I mean banking, credit and currency, power, light, oil and natural gas and our God-given natural resources." Translated: He wants to take power away from the individual, you, and hand it to the government because it is "too important" for individuals to control. Anything that is important can only be trusted to the government, just like how it is under communism.

- 2. A belief "in upholding the right to private property yet in controlling it for the public good." Translated: The government has the right to strip you of your right to private property if it is deemed "for the public good." You better not get on their bad side by exercising freedom of speech or you could lose your house, just like how it is under communism.
- 3. A belief in not only in the right of the laboring man to organize in unions but also in the duty of the Government which that laboring man supports to facilitate and to protect these organizations against the vested interests of wealth and of intellect." Translated: Support workers' right to not only unionize but for the government to do whatever it wants to support the unions in their fight against the evil capitalists. It's an expansion of the government into the private sector. This happens to be supported by, you guessed it, communists. (Just as a side note- According to the US Labor Department, from 2003-2008, states with 9.1% or more of private employees in unions saw private sector employment grow at an average rate of 3.5% compared to over 10% for those states with unionization under 5 %.)
- 4. A belief "in the broadening of the base of taxation founded upon the ownership of wealth and the capacity to pay." Translated: The Progressive tax rate. The more money you earn the higher percentage you pay in taxes. The 1920's demonstrated its failure. What caused the Roaring '20s? A decrease of the top tax rate of 77% in 1920 to 25% from 1925-28 and a 50% cut in spending. People were not taxed as much so they had more money to invest and the economy boomed. It was the largest expansion of the middle class in history, just the opposite of communism.
- 5. A belief "in preferring the sanctity of human rights to the sanctity of property rights (and) that the chief concern of government shall be for the poor because, as it is witnessed, the rich have ample means of their own to care for themselves." Translated: Individual rights mean nothing because of the "greater good." Instead of taking the advice of Calvin Coolidge (who was president during the Roaring '20s) who said, "the wise and correct course to follow in taxation and all other economic legislation is not to destroy those who have already secured success but to create conditions under which everyone will have a better chance to be successful," Coughlin prefers to destroy the successful and by doing so, stop anyone from becoming successful because that is the only

"economically just" thing to do. Everybody is equal. Nobody has anything. Just. Like. Communism.

That short list is just the beginning of what social and economic justice stands for: A massive oppressive government that hides behind the term "greater good." It's the radical left at their worst. And it's endorsed by your very own Stony Brook University.

Part II

Have you ever noticed who two of the colleges within the quads here at the University are named after? Let's take a look:

1. Eleanor Roosevelt. The wife of FDR who championed the Universal Declaration of Human Rights, a doctrine which includes the right to work, which, if enacted, would result in one of two things. Either one, zero percent unemployment, which is horrible for the econ-

omy because there is no longer competition for a job or any reason to work hard because you cannot lose your job (it is a right), or two, skyrocketing unemployment due to the unwillingness of companies to hire workers because they are stuck with them for life because the worker has a "right" to that job.

The UDHR includes the right to unionize which statistics show decreases private-sector job growth. Roosevelt was an activist for the New Deal coalition, "an alignment of interest groups and voting blocs that supported the New Deal and voted for Democratic Presidential candidates from 1932-1968.

2. Margaret Sanger. Sanger was an American eugenicist and the founder of Planned Parenthood who supported sterilizing and segregating those who are mentally challenged. She wanted to "purify" the human race and "placed birth control clinics in

minority neighborhoods to eliminate minority races." Sanger says, "We do not want word to get out that we want to exterminate the Negro population" and that "Birth control must lead ultimately to a cleaner race." Compare her to Adolph Hitler who said, "The demand that defective people be prevented from propagating equally defective offspring...represents the most humane act of mankind."

Stony Brook University named buildings after these people in their honor. I can understand if one disagrees with my take on Roosevelt, but not Sanger. For a university to not only endorse but honor a person with such radical, racist, deadly and oppressive views that are comparable to Adolph Hitler is inexcusable.

Part III

The Continued Use of Affirmative Action

To be fair, this is a SUNY-wide policy, not just SBU. But there is not a doubt in my mind that the University would endorse it anyway. This simply means that race, ethnicity, gender, etc are taken into account when hiring faculty or admitting students. The goal is to end discrimination and to make the playing field "equal" by giving "historically disadvantaged ethnic groups," and women as well, an advantage when applying for a job or to a school.

The problem with this, as it has been demonstrated time and time again over the years, is that it lends itself, ironically, to more discrimination. The discrimination has just been reversed - hence the phrase "reverse-discrimination." As Chief Justice John Roberts wrote in his majority opinion in the case of Parents Involved in Community Schools v. Seattle School District No. 1, "The way to stop discrimination on the basis of race is to stop discrimination on the search of the search of

criminating on the basis of race."

Conservatives have concluded that the best way to achieve this is to make the discriminating factors irrelevant by having the processes become "colorblind." It stops any discrimination and doesn't patronize/insult minorities and women by giving them jobs through the assistance of Affirmative Action because it had been previously concluded that they were incapable of becoming qualified enough to do so on their own.

College should be a place where history is exposed for what it is so the evils of it are not repeated. Instead, it seems that the evils are often glorified. Students need to ask themselves if they are getting the complete picture or if they are only learning one side. Is it really fair to say that students will always be taught the complete picture at this or any other school that so audaciously flaunts its bias? The answer is a resounding no. It is sad, really. Stony Brook advertises itself as a university that is in the top 1% of the world, yet this is the product.

I am in just my 2nd semester on campus,

yet I've been in classrooms where socialism is preached to impressionable freshman weekly. I had a class in which I was taught that Republicans, specifically Reagan, was hypocritical to tell USSR Prime Minister Mikhail Gorbachev to "tear down that wall" because he built a wall with Mexico. The truth is that George W. Bush built a fence with Mexico post-9/11 for national security purposes. Reagan told Gorbachev to "tear down that wall" because he wanted to end the communist oppression imposed by the USSR. I had another class where capitalism was debated against socialism and at the conclusion of the debate, the majority of the students favored socialism due largely in part to what had been taught and the lack of evidence shown that, as the Texas School Board would say, shows the "superiority of American capitalism."

TALES OF A FLIP-FLOPPING LIAR

Stony Brook University is located in CD-1 (Congressional District One) of New York State and our congressman here is Democrat Tim Bishop. Seeing as how the newly enacted Health Care Act effects student loans (cutting the banks out of the equation and replacing them with government), we felt this was, well, important to know. On January 20th, 2010, Tim Bishop released a letter he (supposedly) wrote for the eyes of Nancy Pelosi (which was featured on his website here: http://timbishop.house.gov/index.cfm?sectionid=79&itemid=1654) that said the following:

The Honorable Nancy Pelosi Speaker of the House Room H-232, U.S. Capitol Washington, DC 20515

Dear Speaker Pelosi:

Let me start by commending you and your colleagues on our leadership team for your remarkable work, both in shepherding landmark health care reform through the House of Representatives and in protecting so many policy positions important to the House in your negotiations with the Senate.

Now that we have reached such a crucial yet difficult juncture in our efforts to reform a broken system, I wanted to go on record on two issues of vital importance.

First, as you consider options on a way forward, I urge you not to bring the Senate bill as passed on December 24 to the floor for our consideration. The Senate bill is, in my judgment, flawed in several fundamental respects; I will cite two. [Emphasis added]

One, the excise tax on so-called "Cadillac plans" would subject a number of my constituents to this tax, including a great many who have foregone salary increases for stronger benefits. Further, the fact that it is not properly indexed will subject even more people to the tax in years to come.

Second, and as important, the Senate provision relating to FMAP would represent for New York a \$5 billion swing; the House provisions with respect to FMAP would save New York \$4 billion a year, while the Senate provisions would add \$1 billion annually to New York's yearly Medicaid expenses.

If the Senate bill does come to the floor for a vote, I will have no choice but to vote no. [Emphasis added]

There are many provisions of health care reform which can pass both Houses with bipartisan majorities and improve the quality of health care delivered to New Yorkers and all Americans. By taking immediate action on key insurance reforms and improving affordability, we can lay the groundwork to provide coverage for all Americans. I hope we can quickly craft legislation that incorporates these provisions.

Purpose: To provide unaffordable health care for all Americans at the expense of Small business owners and taxpayers.

Impact of Health Care bill on Small businesses in less than 2,000 pages:

Title I - Introduction: What Obama Promised and What He is Really Doing

President Obama has stated that this health care reform bill will help small businesses, but it will actually do the exact opposite. Susan Eckerly, senior vice president of the National Federation of Independent Business states, "This isn't a health care bill, this is a tax bill wrapped up in health care paper." This bill will increase insurance costs and is hurting the exact people that Obama claimed he wanted to help; small businesses across the country.

Title II - Providing Tax Credit to Very Small Percentages

You are probably thinking, "isn't there a tax credit in this bill? Don't tax credits increase net income? Shouldn't that help small business?" Well, the tax credit that is in this bill will do little to nothing to make purchasing insurance affordable to small firms. Only a small 12 percent of small business owners will actually benefit from this, due to the fact that each company must to go through a variety of very limiting tests to see how much credit they will actually receive. Very few small businesses with employees of 10 or less will receive the full credit. A firm consisting of eleven to twenty-five employees causes the credit to be reduced per employee. Firms with more than 25 employees receive absolutely NO credit. Wages come into factor as well; only firms that pay their workers \$25,000 or less can receive full credit. The credit a company reduces as average wage of employee increases and stops at \$50,000. A firm with 10 or fewer employees has an average wage of about \$27,000, thus proving the point that only a very small percentage of small businesses will receive full credit. The credit is only for a maximum of five years and healthcare costs will continue

to rise after the five years.

Title III: Currently Provide Health Care or Currently Do Not - Either Way You Have to Pay!

If small businesses do not purchase this "qualified" health insurance that the federal government claims is in our "best interest" we will face penalties. Having the federal government make it a requirement to purchase something is unconstitutional. This will impact employers who do and those who do not provide health insurance. If you are an employer who does not offer health insurance you will have to pay a payroll "tax". I choose to put the word tax in quotations due to the fact that it is really an unconstitutional penalty that is being disguised as a tax. Employers must offer "qualified" individual and family coverage and meet premium contribution requirements of at least 72.5% for individuals and 65% for family plans. Employees that do not offer the coverage will have to pay an 8% payroll tax. If an employer offers coverage other than the "qualified" plan, they can be given a penalty of up to \$500,000 a year (\$100 per day). The bill does not even tell us what this so called "qualified" insurance even is.

Title IV: More fees to "help" Small businesses

The bill also contains a "health insurance fee," which will hurt small businesses by taxing them. It will be an annual fee that will begin at \$8 billon in 2014 and will regularly increase to \$14.3 billion in the year 2018. In the consecutive years the fee remains at \$14.3 billion and is annually added to whatever the rate of premium increase is for that year. Health insurers have clearly stated that if there are taxes on the insurers, these new taxes will be passed on as costs to customers; and it is Small businesses that will be paying for this new tax. Since insurers are not going to just pay for this expensive tax on their own, the costs will go to the fully-insured market. The tax excludes big business and labor unions so small businesses will be paying for this since they are buying the fully-insured market's insurance. Policy analysts estimate that family premiums are predicted to increase to a price of at least \$500 per year. Small businesses drive the United States economy and provide jobs for over half of the nation's private workforce so why are we trying to punish them with all of these fees and tear them apart? The restaurant industry will also be hit dramatically from this bill. New jobs that would have been created by the opening of new restaurants will no longer take place because of this tremendous cost burden that this bill will have on the industry. This administered regulation is not reforming but instead it is creating a setback for industry. George Ebinger, board member, New Jersey Restaurant Association, Toms River, N.J., states "I operate three franchises in New Jersey and have a total of 140 employees ... I haven't been able to provide health care because of the cost, and now with the proposed fines, if I don't, I will need to raise my menu [prices] 25 percent to pay the fines or provide care. The past few years have been more trying than any in my past almost 40 years in the business. I don't believe the consumer will understand the reason business prices will increase, [and] customer counts will go down, layoffs will occur and the cycle will continue ... I shudder to think how many small business people will shut the doors as this will put them into the crimson rather than just in the red." This bill will take away the drive of entrepreneurs to start or grow their business because of all the costs and regulations that they will have to follow. With the minimum wage increase of \$7.25 this will put businesses under even more pressure. Steven Berglas, an executive coach in Los Angeles who has written and taught entrepreneurship states that by creating more bureaucratic regulations for entrepreneurial small-business owners, "is like placing a speed-limit sign in front of a Porsche owner."



Socialism is now law in the United States of America.

Let's get the pleasantries out of the way. The newly enacted socialist health care bill will graciously grant us longer wait times, fewer doctors, a massive new bureaucracy, thousands of new IRS agents, and throw trillions of dollars on top of the burning wreckage that is this country's finances.

Medical innovation will be stifled as there will be no money to go towards research and technology. Quality of care will suffer. Costs will skyrocket and taxes will increase. Insurance companies will have their behavior controlled by the state until they are inevitably put out of business. The single payer system is just around the corner.

This new 'healthcare' law has been tried in a multitude of places around the globe. It has failed miserably each and every time, even in the United States. In Massachusetts, universal care was intended to cure overcrowded emergency rooms and reduce costs, when in fact patient visits rose and costs increased 18 percent. The wait time for a mammogram in Italy is 70 days. In Great Britain, 20 percent of patients diagnosed with treatable colon cancer are considered incurable by the time treatment becomes available.

Everywhere you look, wait times are absurd, care is rationed and the newspaper stories read like horror films. Shortages of doctors are common. Greece is estimated to need 5,000 practitioners to meet demand. They have 600. That's 4,400 short because entering the medicine field is no longer worth the time and effort. It's common for patients to offer bribes for appointments. There are thousands upon thousands of similar examples.

Common sense says cross-state competition would reduce costs, and tort reform has been proven to work. Neither is part of the new legislation.

Instead, America has received a government monstrosity destined to fail. Even our existing entitlement programs are a failure. Medicare is hemorrhaging money, sapping the economy, and, like all government programs, is full of waste and fraud. The cost in 1990 was projected to be \$12 billion (with inflation). The actual cost turned out to be \$107 billion. Now, it's far worse. The Medicare system faced nearly \$37 trillion in unfunded liabilities before socialism became law. For good measure, Medicare denies more people more than insurance companies! Medicare had nearly the highest denial rate in the country in 2008, 6.5 percent, far above the average of insurance companies 4.05 percent, 3 percent if you remove an outlier.

This new law even has provisions that reward those who discriminate based on race and someone conveniently forgot to include legislation preventing insurance companies from denying care to sick children, a popular selling point. Oops.

The constitution is being shredded and individual liberties an afterthought. For the first time in history, the United States government is forcing its citizens to buy a product under threat of punishment. This is in direct violation of everything this country was founded upon and our constitution. A government that grants itself this kind of authority is no longer the government of a free people. If the government can do this, there are no limits to the powers it can grant itself.

It is already happening everywhere. New York wants to ban salt, California tried to pass a law that would have allowed it to control the temperatures in your home, you already have next to no control over your child's education, and residents of California are being told they need permits to hold bible studies in their homes. The government just took over 20% of the economy and will only make things worse.

James Madison summed up the situation nicely. "...there are more instances of the abridgement of the freedom of the people by gradual and silent encroachments of those in power than by violent and sudden usurpations."

But hope is not lost. The American people are wising up. Liberalism has finally thrown back the veil and shown itself for what it truly is: statism, socialism and tyranny. Some still fall prey to the cancer of socialism and become nothing more than wards of the state, but more and more Americans are waking up and fighting back against the government takeover of every aspect of our lives.

Will you spend your sunset years telling your children and your children's children what it was once like in the United States where men were free?

Or will you tell them how, even in the darkest of hours, you stood up and let your voice be heard, you made a difference, you moved events, you got involved and voted the socialists out of office, bringing Liberty back to America?

The clock is ticking on the battle for our countries heart and soul. Independence or dependence, freedom or control, liberty or tyranny.

Learn your facts, stand up, be heard. People will flock to a voice of reason amidst the cesspool of lies radiating from Washington. Make a difference. 

Israeli Prime Minister Benjamin Netanyahu received an icy reception at the White House on Mar. 24 from President Barack Obama while discussing the discord involved with Israel's proposal to develop housing in East Jerusalem.

The face-to-face meeting was instead devoted to shooting down one Israeli compromise offer after another.

After failing to obtain negotiations on settlements, Obama excused himself from the meeting to have a private dinner, inviting Netanyahu to stay at the White House to consult with advisers and "let me know if there is anything new," a US congressman who spoke to the Prime Minister said.

Netanyahu did not pose for pictures and there was no official statement about the private meeting from Obama and Netanyahu.

Rather than risk being eavesdropped on a White House telephone line, Netanyahu left the White House disrespected and surely with a bitter feeling toward the U.S., its supposed greatest ally.

Israel's housing development plan in East Jerusalem is to construct 1,600 residential units in the Shepherd Hotel compound in Sheik Jarrah, a neighborhood populated mostly by Palestinians, and more recently by Israelis north of the Old City.

Israel captured East Jerusalem from Jordan in the 1967 Six Day War, but its annexation was never internationally recognized. The Palestinians claim East Jerusalem as the capital of a future state and demand a halt to Israeli expansion in the occupied territories, includ-




ing East Jerusalem, before Israeli-Palestinian negotiations can start.

Obama does not want Israeli housing plans to develop further because he believes doing so will reverse the steps that have already been made to mend ties in Israel and Palestine.

How high should taxes be? The answer: taxes are for losers. Incomes are on average underreported by 10 percent leading to a 25 percent shortfall in tax receipts. The


government's answer has been to increase taxes, while the people's answer has been to not pay them.
